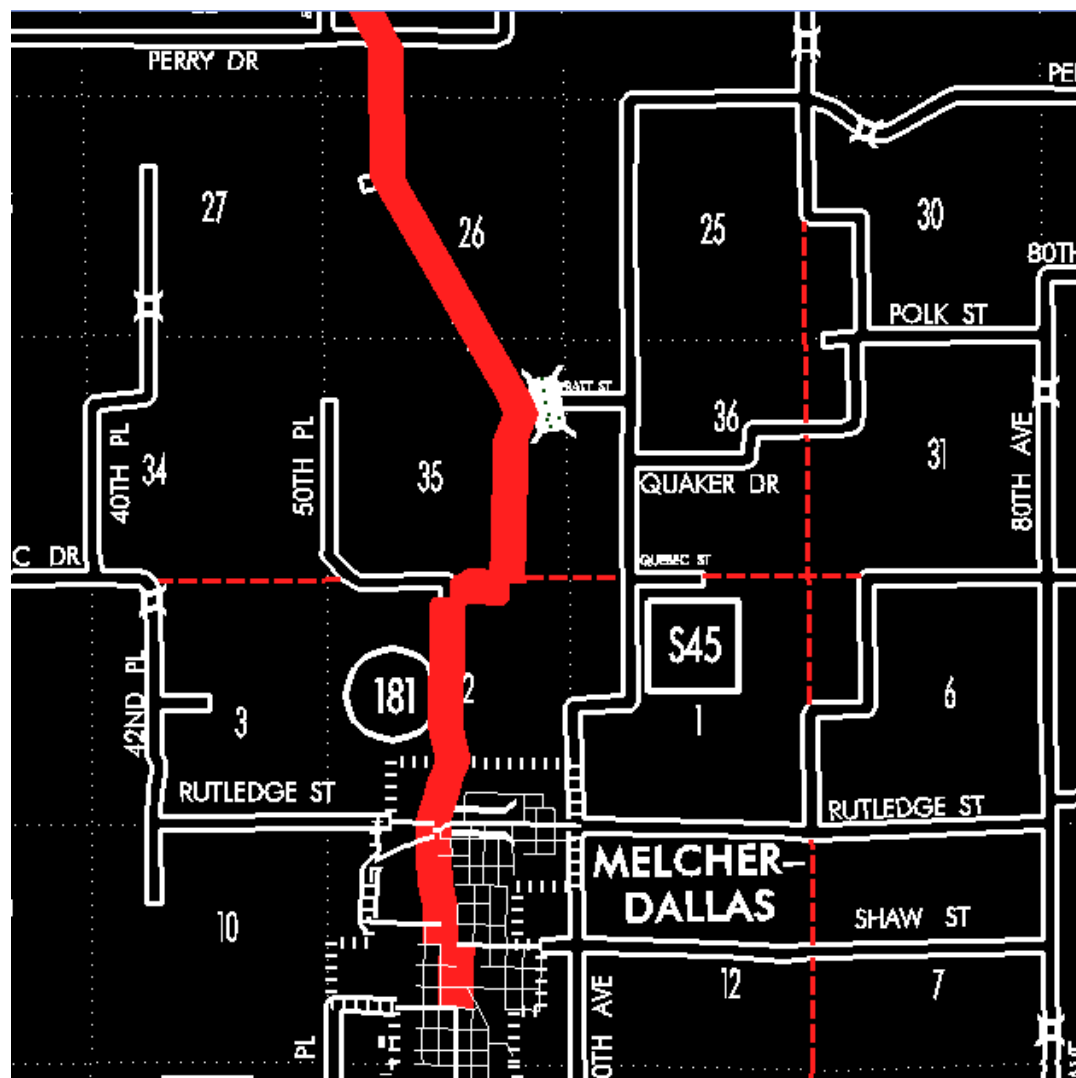

DISCUSSION/BACKGROUND:

Senate File 451 transferred Iowa 181 in its entirety, in Marion County, to city and county jurisdiction on July 1, 2003.



New description – Iowa 181 and its extensions in Marion County described as follows:

Melcher:

Beginning on Main Street at "A" Street SW; thence north on Main Street to "B" Street NW; thence west on "B" Street NW to 1st Street NW; thence north on 1st Street NW to the north corporation line (south corporation line of Dallas).

Dallas:

Beginning on an unnamed street at the south corporation line (north corporation line of Melcher); thence northerly on unnamed street to the north corporation line.

Beginning on the north corporation line of Dallas connecting with an unnamed street; thence in a northerly, northeasterly, northerly and northwesterly direction through Section 2-T74N-R21W and Sections 35, 26, 23, 22, and 15-T75N-R21W to a point approximately 1,100 feet north of the center of Section 15-T75N-R21W; thence northerly following substantially the center section line of Sections 15, 10, and 3-T75N-R21W and Sections 34 and 27-T76N-R21W to the junction of Iowa 5 and Iowa 92 at a point approximately 800 feet south of the center of Section 27-T76N-R21W.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 181 in Marion County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 181 begins in Melcher, Iowa and travels northerly via Melcher and Dallas, Iowa terminating at the junction of Iowa 5 and Iowa 92 approximately 82 miles north of Dallas, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 181 and its extensions in Marion County as follows:

Melcher:

Beginning on the south line of south "A" Street; thence northerly, westerly, and northerly to the north corporation line (south corporation line of the City of Dallas) connecting with an unnamed street.

Dallas:

Beginning on the south corporation line (north corporation line of the City of Melcher) connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Dallas connecting with an unnamed street; thence in a northerly, northeasterly, northerly, and northwesterly direction through Section 2-T74N-R21W and Sections 35, 26, 23, 22, and 15-T75N-R21W to a point approximately 1100 feet north of the center of Section 15-T75N-R21W; thence northerly following substantially the center section line of Sections 15, 10, and 3-T75N-R21W and Sections 34 and 27-T76N-R21W to the junction of Iowa 5 and Iowa 92 at a point approximately 800 feet south of the center of Section 27-T76N-R21W.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 181 in Marion County, Iowa.
