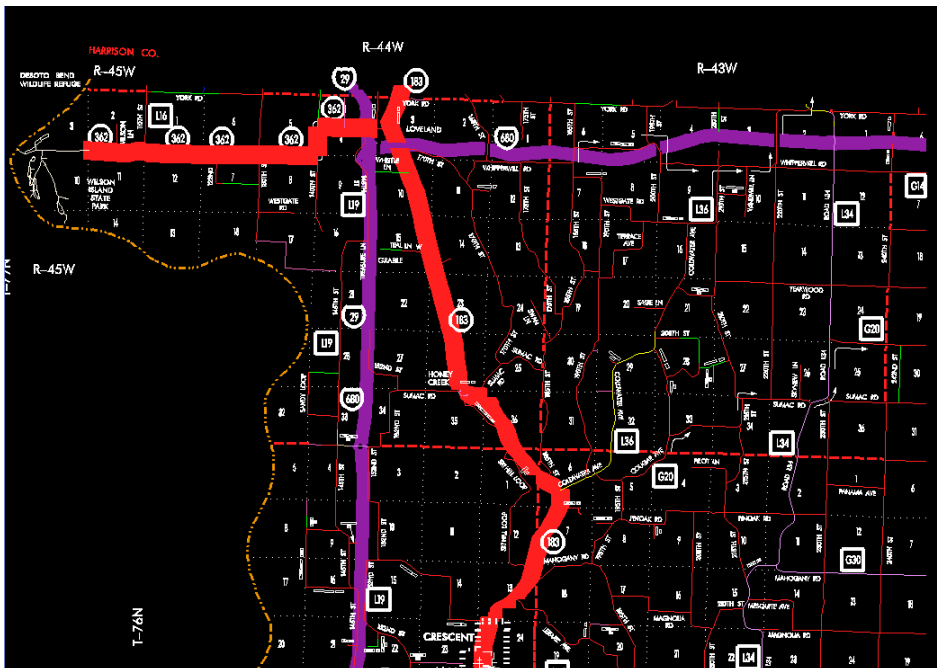

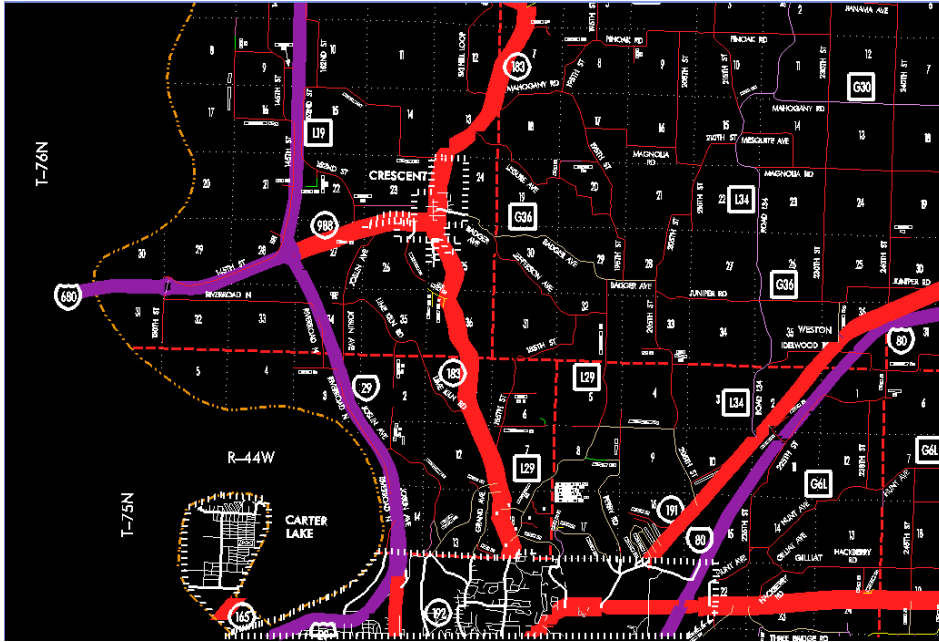

New description Iowa 183 and its extension in Pottawattamie County described as follows:

Beginning at the north corporation line of Council Bluffs connecting with North Broadway Street; thence in a northerly and northwesterly direction through Sections 18 and 7-T75N-R43W; thence in a general northwesterly and northeasterly direction through Sections 12 and 1-T75N-R44W and Sections 36 and 25-T76N-R44W to the south corporation line of Crescent connecting with Lincoln Highway Street.

Crescent:

Beginning on Lincoln Highway Street at the south corporation line; thence north on Lincoln Highway Street to the north corporation line.

Beginning again on the north corporation line of Crescent connecting with Lincoln Highway Street; thence in a northeasterly and northerly direction through Section 13-T76N-R44W and Section 18-T76N-R43W; thence in a northeasterly direction through Sections 7 and 6-T76N-R43W; thence in a northwesterly direction through Section 6-T76N-R43W Section 1-T76N-R44W and Sections 36, 35, 26, 23, 14, 15, 10 and 3-T77N-R44W; thence northeasterly through Section 3-T77N-R44W to the Pottawattamie-Harrison County line at a point on the north line of Section 3-T77N-R44W, Pottawattamie County (south line of Section 34-T78N-R44W, Harrison County).

Iowa 183 begins at US 6 in the City of Council Bluffs, and travels generally northerly via the City of Crescent to the Pottawattamie-Harrison County line approximately three miles south of the City of Missouri Valley.

Transfer of jurisdiction agreement number TJ-183-0(15) between the City of Council Bluffs and the Iowa Department of Transportation transferred that portion of Iowa 183 from Broadway Street (junction US 6) north to the north corporation line to city jurisdiction on October 20, 1981. Iowa 183 in Pottawattamie County and the City of Crescent remain unchanged.

Locate Iowa 183 and its extension in Pottawattamie County as follows:

Beginning on the north corporation line of the City of Council Bluffs connecting with an unnamed street; thence in a northerly and northwesterly direction through Sections 18 and 7-T75N-R43W; thence in a general northwesterly and northeasterly direction through Sections 12 and 1-T75N-R44W and Sections 36 and 25-T76N-R44W to the south corporation line of the City of Crescent connecting with an unnamed street.

Crescent:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street to the north corporation line.

Beginning again on the north corporation line of the City of Crescent connecting with an unnamed street; thence in a northeasterly and north-easterly direction through Section 13-T76N-R44W and Section 18-T76N-R43W; thence in a northeasterly direction through Sections 7 and 6-T76N-R43W; thence in a northwesterly direction through Section 6-T76N-R43W, Section 1-T76N-R44W and Sections 36, 35, 26, 23, 14, 15, 10 and 3-T77N-R44W; thence northeasterly through Section 3-T77N-R44W to the Pottawattamie-Harrison County line at a point on the north line of Section 3-T77N-R44W, Pottawattamie County (south line of Section 34-T78N-R44W, Harrison County).

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 183 in Pottawattamie County from the primary road system and approve including the attached new description of Iowa 183 in the primary road system.

Due to a review of our Primary Road System records, Iowa 183 in Pottawattamie County should be deleted and the new description added should be officially included into the Primary System.

Iowa 183 begins at US 6 in Council Bluffs and travels in a generally northwesterly direction via Council Bluffs and Crescent to the Pottawattamie-Harrison County line approximately 5 miles east of the Missouri River.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 183 and its extensions in Pottawattamie County as follows:

Council Bluffs:

Beginning on an unnamed street at Broadway Street (junction US 6); thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Council Bluffs connecting with an unnamed street; thence in a northerly and northwesterly direction through Sections 18 and 7-T75N-R43W; thence in a general northwesterly and northeasterly direction through Sections 12 and 1-T75N-R44W and Sections 36 and 25-T76N-R44W to the south corporation line of the City of Crescent connecting with an unnamed street.

Crescent:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street to the north corporation line.

Beginning again on the north corporation line of the City of Crescent connecting with an unnamed street; thence in a northeasterly and northerly direction through Section 13-T76N-R44W and Section 18-T76N-R43W; thence in a northeasterly direction through Sections 7 and 6-T76N-R43W thence in a northwesterly direction through Section 6-T76N-R43W, Section 1-T76N-R44W and Sections 36, 35, 26, 23, 14, 15, 10 and 3-T77N-R44W; thence northeasterly through Section 3-T77N-R44W to the Pottawattamie-Harrison County line at a point on the north line of Section 3-T77N-R44W, Pottawattamie County (south line of Section 34-T78N-R44W, Harrison County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 183 in Pottawattamie County, Iowa.

Crescent:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street to the north corporation line.
