**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number 2001-TJ-009, between the City of Creston and the Iowa Department of Transportation, transferred that portion of Iowa 186 from Lincoln Street at Townline Street (junction of Iowa 25); then north on Lincoln Street to the north corporation line to city jurisdiction on December 17, 2001.

Transfer of jurisdiction agreement number 2001-TJ-008, between Union County and the Iowa Department of Transportation, transferred that portion of Iowa 186 from the north corporation line of the City of Creston connecting with Lincoln Street; then north following substantially the section line of Sections 36, 25, and 24-T73N-R31W to a point near the NW Corner Section 24-T73N-R31W; then west following substantially the section line of Section 23-T73N-R31W to the entrance of Green Valley State Park at a point approximately 1900 feet west of the NE Corner Section 23-T73N-R31W to county jurisdiction on November 12, 2001.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve deleting the present description of Iowa 186 and its extensions in Union County from the Primary Road System.

New Description – Iowa 186 and its extension in Union County described as follows:

Creston:

Beginning on Lincoln Street at Townline Street (junction Iowa 25); then north on Lincoln Street to the north corporation line.

Beginning again on the north corporation line of Creston connecting with Lincoln Street; then north following substantially the section line of Sections 36, 25 and 24-T73N-R31W to a point near the NW Corner Section 24-T73N-R31W; then west following substantially the section line of Section 23-T73N-R31W to the entrance of Green Valley State Park at a point approximately 1,900 feet west of the NE Corner Section 23-T73N-R31W.

**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number TJ-000-0 (2)-2M-88, between the City of Creston and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-000-0 (1)--2M-88, between Union County and the Iowa Department of Transportation, transferred the section of road from Iowa 25 at Lincoln Street in the City of Creston north and west to the entrance of Green Valley State Park approximately 1900 feet west of the NE Corner Section 23-T73N-R31W to state jurisdiction on October 1, 1980. The section is now designated Iowa 186.

Iowa 186 begins in the City of Creston and proceeds north and west to the entrance to Green Valley State Park approximately two and one-half miles north of the City of Creston.

#### **PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve including the attached description of Iowa 186 in Union County in the primary road system.

Locate on the primary road system Iowa 186 and its extension in Union County as follows:

Creston:

Beginning on an unnamed street at a junction with Iowa 25; thence north to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Creston connecting with an unnamed street; thence north following substantially the section line of Sections 36, 25 and 24-T73N-R31W to a point near the NW Corner Section 24-T73N-R31W; thence west following substantially the section line of Section 23-T73N-R31W to the entrance of Green Valley State Park at a point approximately 1900 feet west of the NE Corner Section 23-T73N-R31W.
