**DISCUSSION/BACKGROUND:**

Iowa 187 begins on the Delaware-Buchanan County line approximately two miles west of Backbone State Park and travels easterly to Backbone State Park.

Transfer of jurisdiction agreement number TJ-187-0 (1)--2M-28, between Delaware County and the Iowa Department of Transportation, transferred that portion of Iowa 187 from the Delaware-Buchanan County line near the NW Corner Section 18-T90N-R6W easterly to the entrance of Backbone State Park near the NE Corner Section 17-T90N-R6W to county jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 187 in Delaware County from the primary road system.

Remove Iowa 187 in Delaware County as follows:

Beginning on the Delaware-Buchanan County line at a point near the NW Corner of Section 18-T90N-R6W, Delaware County (NE Corner of Section 13-T90N-R7W, Buchanan County); thence easterly following substantially the section line of Sections 18 and 17-T90N-R6W to the entrance of Backbone State Park at a point near the NE Corner of Section 17-T90N-R6W.

Beginning on the Delaware–Buchanan County line at a point near the NW Corner of Section 18–T90N–R6W, Delaware County (NE Corner of Section 13–T90N–R7W, Buchanan County); thence easterly following substantially the section line of Sections 18 and 17–T90N–R6W to the entrance of Backbone State Park at a point near the NE Corner of Section 17–T90N–R6W.
