New description – Iowa 188 and its extensions in Butler County described as follows:

Beginning at a point near the N $\frac{1}{4}$ Corner of Section 31-T92N-R15W (junction of Iowa 3); thence northerly following substantially the center section line of Sections 30 and 19-T92N-R15W to a point approximately 800 feet south of the center of Section 19-T92N-R15W; thence northwesterly through said Section 19 to the south corporation line of Clarksville connecting with Main Street.

Clarksville:

Beginning on Main Street at the south corporation line; thence northerly on Main Street to the north corporation line.

Beginning again at the north corporation line of Clarksville connecting with Main Street; thence north through the west part of Sections 7 and 6-T92N-R15W to the N $\frac{1}{4}$ Corner of the NW $\frac{1}{4}$ of Section 6-T92N-R15W; thence northwesterly through Section 31-T93N-R15W to a point approximately 815 feet north of the W $\frac{1}{4}$ Corner of Section 31-T93N-R15W; thence north following substantially the section line of Sections 31 and 30-T93N-R15W to near the NW Corner of Section 30-T93N-R15W; thence east following substantially the Section line of Sections 30, 29, 28, 27, 26, and 25-T93N-R15W to the Butler-Bremer County line at the NE Corner of Section 25-T93N-R15W, Butler County (NW Corner Section 30-T93N-R14W, Bremer County).

It is recommended that the old description of Iowa 188 in Butler County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 188 and its extension in Butler County as follows:

Beginning at a point near the N $\frac{1}{4}$ Corner of Section 31-T92N-R15W (junction of Iowa 3); thence northerly following substantially the center section line of Sections 30 and 19-T92N-R15W to a point approximately 800 feet south of the center of Section 19-T92N-R15W; thence northwesterly through said Section 19 to the south corporation line of the City of Clarksville connecting with an unnamed street.

Clarksville:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Clarksville connecting with an unnamed street; thence north through the west part of Sections 7 and 6-T92N-R15W to the N ¼ Corner of the NW ¼ of Section 6-T92N-R15W; thence northwesterly through Section 6-T92N-R15W and Section 31-T93N-R15W to a point approximately 815 feet north of the W ¼ Corner of Section 31-T93N-R15W; thence north following substantially the section line of Sections 31 and 30-T93N-R15W to near the NW Corner of Section 30-T93N-R15W; thence east following substantially the Section line of Sections 30, 29, 28, 27, 26, and 25-T93N-R15W to the Butler-Bremer County line at the NE Corner of Section 25-T93N-R15W, Butler County (NW Corner Section 30-T93N-R14W, Bremer County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 188 in Butler County should be deleted and the new description added should be officially included into the Primary System.

Iowa 188 begins at the junction of Iowa 3 approximately 1 ½ miles south of Clarksville and travels northerly and easterly through Clarksville to the Butler-Bremer County line approximately 4 miles north and 6 miles east of Clarksville.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 188 and its extensions in Butler County as follows:

Beginning at a point near the N $\frac{1}{4}$ Corner of Section 31-T92N-R15W (junction of Iowa 3); thence northerly following substantially the center section line of Sections 30 and 19-T92N-R15W to a point approximately 800 feet south of the center of Section 19-T92N-R15W; thence northwesterly to the south corporation line of the City of Clarksville connecting with an unnamed street.

Clarksville:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Clarksville connecting with an unnamed street; thence north through the west part of Sections 7 and 6-T92N-R15W to the N $\frac{1}{4}$ Corner of the NW $\frac{1}{4}$ of Section 6-T92N-R15W; thence northwesterly to a point approximately 815 feet north of the W $\frac{1}{4}$ Corner of Section 31-T93N-R15W; thence north following substantially the section line of Sections 31 and 30-T93N-R15W to the NW Corner of Section 30-T93N-R15W; thence east following substantially the Section line of Sections 30, 29, 28, 27, 26, and 25-T93N-R15W to the Butler-Bremer County line at the NE Corner of Section 25-T93N-R15W, Butler County (NW Corner Section 30-T93N-R14W, Bremer County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 188 in Butler County, Iowa.

Beginning at a point approximately 600 feet west of the S $\frac{1}{4}$ Corner of Section 30-T92N-R15W; thence curving in a northeasterly direction to a point approximately 600 feet north of the S $\frac{1}{4}$ Corner of said Section 30; thence north to a point approximately 800 feet south of the center of Section 19-T92N-R15W; thence northwesterly about $\frac{1}{4}$ mile to the south corporation line of the Town of Clarksville connecting with Main Street.

Clarksville:

Beginning on the south corporation line connecting with Main Street; thence northerly along Main Street to the north corporation line.

Beginning again at the north corporation line of the Town of Clarksville connecting with Main Street; thence north to the N $\frac{1}{4}$ Corner of the NW $\frac{1}{4}$ of Section 6-T92N-R15W; thence northwesterly to a point approximately 815 feet north of the E $\frac{1}{4}$ Corner of Section 36-T93N-R16W; thence north following substantially the section line to the SW Corner of Section 19-T93N-R15W; thence east following substantially the section line to the Butler-Bremer County line at the SE Corner of Section 24-T93N-R15W, Butler County (SW Corner of Section 19-T93N-R14W, Bremer County).

Beginning again at the north corporation line of the Town of Clarksville, connecting with Min Street; thence north approximately 2-1/2 miles and west approximately $\frac{1}{4}$ mile to the W $\frac{1}{4}$ Cor. Sec. 31-t93-R15; thence north 1-1/2 miles to the SW Cor. Sec. 19-T93-R5; thence east following substantially the section line to the SE Cor. Sec. 24-T93-R15 (Butler County) SW Cor. Sec. 19-T93-R14 (Bremer County).
