Plainfield:

Beginning on 1st Street at the west corporation line; thence east on 1st Street to the east corporation line.

Beginning again at the east corporation line of Plainfield connecting with 1st Street; thence east following substantially the section line of Sections 29, 28, 27, 26, and 25–T93N–R14W continuing east following substantially the section line of Sections 30, 29, 28, 27, and 26–T93N–R13W to a point near the NE Corner of Section 26–T93N–R13W (intersection with US 63).

Due to a review of the Primary Road System records, Iowa 188 in Bremer County should be deleted and the new description should be officially included into the Primary System.

Beginning at the Bremer–Butler County line at the NW Corner of Section 30–T93N–R14W, Bremer County (NE Corner of Section 25–T93N–R15W, Butler County); thence east following substantially the section line of Section 30–T93N–R14W to the west corporation line of the City of Plainfield connecting with an unnamed street.

Plainfield:

Beginning at the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of Plainfield connecting with an unnamed street; thence easterly following substantially the section line of Sections 29, 28, 27, 26, and 25-T93N-R14W continuing easterly following substantially the section line of Sections 30, 29, 28, 27, and 26-T93N-R13W to a point in the NE Corner of Section 26-T93N-R13W (intersection with US 63).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 138 in Bremer County, Iowa.
