New Description – Iowa 191 and its extension in Harrison County described as follows:

Beginning on the Harrison-Pottawattamie County line at a point approximately 800 feet east of the SW Corner of Section 32-T78N-R41W, Harrison County (NW Corner of Section 5-T77N-R41W, Pottawattamie County); thence in a northerly and northeasterly direction through Section 32 and 29-T78N-R41W to a point approximately $\frac{1}{4}$ mile west and 1,500 feet south of the NE Corner of Section 29-T78N-R41W; thence north through Sections 29 and 20-T78N-R41W to a point approximately $\frac{1}{4}$ mile west of the NE Corner of Section 20-T78N-R41W; thence in a northeasterly direction through Sections 17, 16, and 9-T78N-R41W to the south corporation line of Persia, connecting with 1st Street.

Persia:

Beginning on 1st Street at the south corporation line; thence northeasterly on 1st Street to the north corporation line.

Beginning again on the north corporation line of Persia, connecting with 1st Street; thence in a northeasterly direction through Section 4-T78N-R41W to the Harrison-Shelby County line at a point near the NE Corner of Section 4-T78N-R41W, Harrison County (SW Corner of Section 31-T79N-R40W, Shelby County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records Iowa 191 in Harrison County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 191 in Harrison County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 191 and its extension in Harrison County as follows:

Beginning on the Harrison-Pottawattamie County line at a point approximately 800 feet east of the SW Corner of Section 32-T78N-R41W Harrison County, (NW Corner of Section 5-T77N-R41W, Pottawattamie County); thence in a northerly and northeasterly direction through Section 32 and 29-T78N-R41W to a point approximately mile west and 1500 feet south of the NE Corner of Section 23-T78N-R41W; thence north through Sections 29 and 20-T78N-R41W to a point approximately ¼ mile east of the NE Corner of Section 20-T78N-R41W; thence in a northeasterly direction through Sections 17, 16 and 9-T78N-R41W to the south corporation line of the City of Persia, connecting with an unnamed street.

Persia:

Beginning on the south corporation line connecting with an unnamed street: thence northeasterly and northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Persia, connecting with an unnamed street; thence in a northeasterly direction through Section 4-T78N-R41W to the Harrison-Shelby County line at a point near the NE Corner of Section 4-T78N-R41W, Harrison County (a point approximately 300 feet east of the SW Corner of Section 31-T79N-R40W, Shelby County).

Beginning on the Harrison-Pottawattamie County line at a point approximately 800 feet east of the SW Corner of Section 32-T78N-R41W, Harrison County (NW Corner of Section 5-T77N-R41W, Pottawattamie County); thence in a northerly and northeasterly direction through Section 32 and 29-T78N-R41W to a point approximately $\frac{1}{4}$ mile west and 1500 feet south of the NE Corner of Section 29-T78N-R41W; thence north to a point approximately $\frac{1}{4}$ mile west of the NE Corner of Section 20-T78N-R41W; thence in a northeasterly direction to a point on the west side of the Chicago, Milwaukee, St. Paul and Pacific Railroad approximately 1700 feet south and 200 feet west of the NE Corner of Section 17-T78N-R41W; thence in a northeasterly direction along the west side of said railroad and substantially parallel thereto through Section 17, 16, and 9-T78N-R41W to the south corporation line of the Town of Persia, connecting with Railway Street.

Beginning again on the north corporation line of the Town of Persia, connecting with Railway Street; thence in a northeasterly direction along the west side of the Chicago, Milwaukee, St. Paul, and Pacific Railroad and substantially parallel thereto to the Harrison–Shelby County line at a point near the NE Corner of Section 4–T78N–R41W, Harrison County (a point approximately 300 feet east of the SW Corner of Section 31–T79N–R40W, Shelby County).
