



DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number 2017-TJ-002, between the City of Council Bluffs and the Iowa Department of Transportation, transferred the following described section of road to the City of Council Bluffs on December 22, 2017.

Council Bluffs:

Beginning at the north ramp of Interstate 29 and 80 and US 6, thence northerly to a junction with Broadway Avenue.

Also with a spur:

Beginning at the intersection of Broadway Avenue and South Seventh Street (begin one-way southbound); thence south to Sixth Avenue (end one-way southbound).

PROPOSAL/ACTION RECOMMENDATION:

New Description – Iowa 192 in Pottawattamie County described as follows:

Council Bluffs:

Beginning at the south ramp of Interstate 29 and 80 and US 6 and Thirtieth Avenue, thence northerly to the north ramp of Interstate 29 and 80 and US 6.

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number 2016-TJ-002, between the City of Council Bluffs and the Iowa Department of Transportation, transferred the following described section of road to the City of Council Bluffs on May 13, 2016.

Council Bluffs:

Beginning at the junction of Broadway Avenue to another junction with Broadway Avenue and North Sixteenth Street northerly to Interstate 29 at North Sixteenth Street.

Also with a spur:

Beginning at Interstate 29 and North Sixteenth Street (begin one-way southbound); south to North Sixteenth Street (end one-way southbound).

PROPOSAL/ACTION RECOMMENDATION:

New Description – Iowa 192 in Pottawattamie County described as follows:

Council Bluffs:

Beginning at the south ramp of Interstate 29 and 80 and Thirtieth Avenue; thence northerly to a junction with Broadway Avenue.

Also with a spur:

Beginning at the intersection of Broadway Avenue and South Seventh Street (begin one-way southbound); thence south to Sixth Avenue (end one-way southbound).

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number TJ-000-0(4)--2M-78, between the City of Council Bluffs and the Iowa Department of

Transportation, transferred the following described section of road to state jurisdiction on July 1, 1980. The section is now designated Iowa 192.

Iowa 192 commences on Piute Street at the south ramps of Interstate 29 & 80 in Council Bluffs and travels northerly, westerly and northerly to the interchange with Interstate 29 at north Sixteenth Street in Council Bluffs.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve including the attached description of Iowa 192 in Pottawattamie County in the primary road system.

Locate Iowa 192 in Pottawattamie County as follows:

Council Bluffs:

Beginning at the south ramp of Interstate 29 and 80 and Piute Street; thence northerly to a junction with US 6 (Broadway Avenue) and from another junction with US 6 (Broadway Avenue) northerly to Interstate 29 at North Sixteenth Street.

Also with a spur:

Beginning at Interstate 29 and North Sixteenth Street (begin one-way southbound); south to North Sixteenth Street (end one-way southbound).

Also with a spur:

Beginning at the intersection of US 6 (Broadway Avenue) and South Seventh Street (begin one-way southbound); thence south to Sixth Avenue (end one-way southbound).

DISCUSSION/BACKGROUND:

In accordance with agreement between the City of Council Bluffs and the Iowa Department of Transportation, it is recommended that Iowa 192 be removed from the Primary Road System and revert to the City Street System of Council Bluffs.

PROPOSAL/ACTION RECOMMENDATION:

Remove from Iowa 192 extension in Pottawattamie County, Iowa as follows:

Beginning approximately 1820 feet south of Iowa 92 connecting with South Fourth Street; thence northerly on South Fourth Street to a point approximately 270 feet north of 23rd Avenue; thence northwesterly on an unnamed street to a point approximately 50 feet north of 18th Avenue and midway between South Sixth Street and South Seventh Street; thence northerly on an unnamed street to 16th Avenue at a point approximately midway between South Sixth Street and South Seventh; thence easterly on 16th Avenue to South Main Street; thence northerly to 9th Avenue; thence easterly on 9th Avenue to Fourth Street; thence northerly on Fourth Street to West Broadway.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 192 extension be removed in the City of Council Bluffs.
