

Huxley:

Beginning at the west corporation line, then east to the east corporation line.

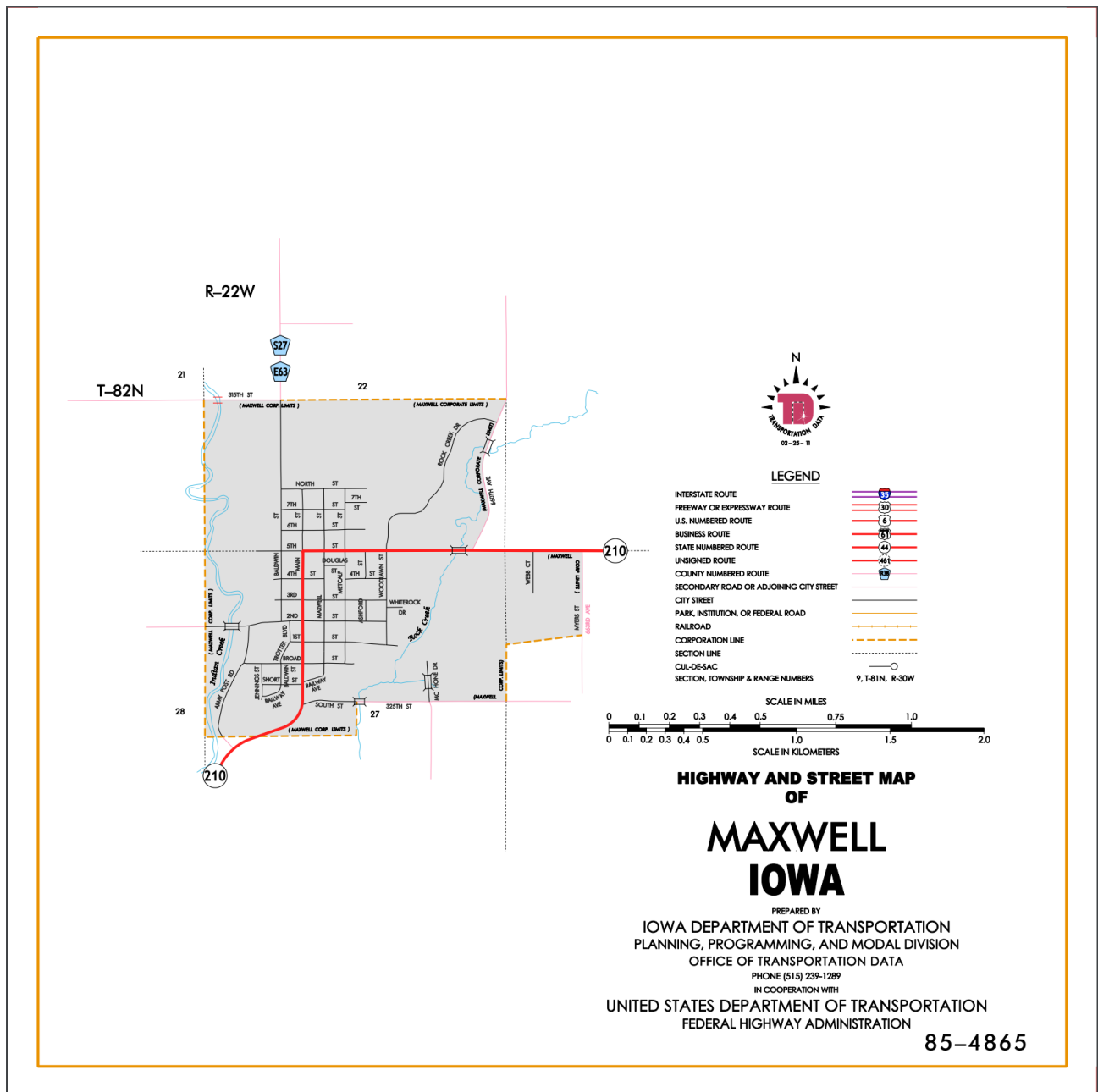
Beginning again at the east corporation line of Huxley; thence east following substantially the section line of Section 31 T82N-R23W to the west corporation line of Huxley.

Huxley:

Beginning at the west corporation line, then east through the junction of Interstate 35 to the east corporation line.

Beginning again at the west corporation line of Huxley; thence east following substantially the section line of Sections 32, 33, 34, 35 and 36-T82N-R23W and Sections 31, 32 and 33-T82N-R22W to a point approximately 4,200 feet east of the NW Corner Section 33-T82N-R22W; thence curving northeasterly

through Sections 28 and 27-T82N-R22W to the south corporation line of Maxwell, connecting with Main Street.



Maxwell:

Beginning on Main Street at the south corporation line; thence northeast and north on Main Street to 5th Street; thence east on 5th Street to the east corporation line.

Beginning again on the east corporation line of Maxwell connecting with 5th street; thence east following substantially the section line of Sections 26 and 25-T82N-R22W and Sections 30 and 29-T82N-R21W to a point near the NE Corner Section 29-T82N-R21W (junction US 65).

New Description – Iowa 210 and its extensions in Story County described as follows:

Beginning on the Story-Boone County line at a point near the NW Corner Section 31-T82N-R24W, Story County (NE Corner Section 36-T82N-R25W, Boone County); thence east following substantially the section line of Section 31-T82N-R24W to the west corporation line of Slater, connecting with 6th Avenue.

Slater:

Beginning on 6th Avenue at the west corporation line; thence east on 6th Avenue to the east corporation line.

Beginning again on the east corporation line of Slater connecting with 6th Avenue; thence east following substantially the section line of Sections 32, 33, 34, 35 (junction US 69) and 36-T82N-R24W; Section 31 (junction Interstate 35), 32, 33, 34, 35 and 36-T82N-R23W and Sections 31, 32 and 33-T82N-R22W to

a point approximately 4,200 feet east of the NW Corner Section 33-T82N-R22W; thence curving northeasterly through Sections 28 and 27-T82N-R22W to the south corporation line of Maxwell, connecting with Main Street.

Maxwell:

Beginning on Main Street at the south corporation line; thence northeast and north on Main Street to 5th Street; thence east on 5th Street to the east corporation line.

Beginning again on the east corporation line of Maxwell connecting with 5th street; thence east following substantially the section line of Sections 27, 26, 25-T82N-R22W and Sections 30 and 29-T82N-R21W to a point near the NE Corner Section 29-T82N-R21W (junction US 65).

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement numbers TJ-89-3 (4) --2M-85 and TJ-89-3 (5) --2M-85, between Story County and the Iowa Department of Transportation, transferred the sections of road from the Story-Boone County line near the NW Corner Section 31-T82N-R24W east to the west corporation line of the City of Slater and from the east corporation line of the City of Maxwell east to a junction with US 65 near the NE Corner Section

29-T82N-R21W to state jurisdiction on August 25, 1980. These sections are now designated Iowa 210.

Transfer of jurisdiction agreement number TJ-89-3(2)--2M-85, between the City of Slater and the Iowa Department of Transportation, transferred the section of road on Sixth Avenue from the west corporation line east to present Iowa 210 at Linn Street to state jurisdiction on July 1, 1980. The section is now designated Iowa 210.

Transfer of jurisdiction agreement number TJ-89-3(3)--2M-85, between the City of Maxwell and the Iowa Department of Transportation, transferred the section of road from present Iowa 210 at Second Street north on Main Street and east on Fifth Street to the east corporation line of the City of Maxwell to state jurisdiction on July 1, 1980. The section is now designated Iowa 210.

Iowa 210 begins at the Story-Boone County line approximately one-quarter mile west of the City of Slater and proceeds easterly via the cities of Slater and Maxwell to a junction with US 65 approximately one-half mile south of the City of Collins.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 210 in Story County from the primary road system and approve including the attached new description of Iowa 210 in the primary road system.

Locate Iowa 210 and its extension in Story County as follows:

Beginning on the Story-Boone County line at a point near the NW Corner Section 31-T82N-R24W, Story County (NE Corner Section 36-T82N-R25W, Boone County); thence easterly following substantially the section line of Section 31-T82N-R24W to the west corporation line of the City of Slater connecting with an unnamed street.

Slater:

Beginning again on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Slater connecting with an unnamed street; thence easterly following substantially the section line of Sections 32, 33, 34, 35 (junction US 69) and 36-T82N-R24W; Section 31 (junction Interstate 35), 32, 33, 34, 35, and 36-T82N-R23W and Sections 31, 32, and 33-T82N-R22W to a point approximately 4200 feet east of the NW Corner Section 33-T82N-R22W; thence curving northeasterly through Sections 28 and 27-T82N-R22W to the south corporation line of the City of Maxwell connecting with an unnamed street.

Maxwell:

Beginning again on the south corporation line connecting with an unnamed street; thence northerly and easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Maxwell connecting with an unnamed street; thence easterly following substantially the section line of Sections 27, 26 and 25-T82N-R22W to a point approximately 422 feet west of the NE Corner Section 25-T82N-R22W; thence northeasterly and southeasterly through Section 24-T82N-R22W and Section 19-T82N-R21W to a

point approximately 370 feet east of the NW Corner Section 30-T82N-R21W; thence easterly following substantially the section line of Sections 30 and 29-T82N-R21W to a point near the NE Corner Section 29-T82N-R21W (junction US 65).

DISCUSSION/BACKGROUND:

Iowa 210 begins in Slater and travels generally easterly to a point in Maxwell, Iowa.

In accordance with agreement number 78-6-023 between the Iowa Department of Transportation and the City of Slater, dated February 21, 1978, the portion of Iowa 210 in Slater located on Linn Street between Sixth Avenue and Main Street and on Main Street between Linn Street and Story Street should be removed from the Iowa Primary Road System and reverted to the City of Slater.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 210 in Story County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective September 26, 1978.

Locate Iowa 210 and its extensions in Story County as follows:

Slater:

Beginning on an unnamed street at Linn Street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Slater connecting with an unnamed street; thence easterly following substantially the section line of Sections 32, 33, 34, 35 (junction US 69) and 36-T82N-R24W; Section 31 (junction Interstate 35), 32, 33, 34, 35, and 36-T82N-R23W and Sections 31, 32, and 33-T82N-R22W to a point approximately 4200 feet east of the NW Corner Section 33-T82N-R22W; thence curving northeasterly through Sections 28 and 27-T82N-R22W to the south corporation line of the City of Maxwell connecting with an unnamed street.

Maxwell:

Beginning on the south corporation line connecting with an unnamed street; thence in a northerly direction on an unnamed street to Second Street.
