Transfer of jurisdiction agreement numbers 90-TJ-009-14 and 90-TJ-010-14 between the Iowa Department of Transportation, Carroll County and the City of Breda, transferred Iowa 217 to local jurisdiction on December 31, 1989. The present description of Iowa 217 should be deleted to reflect this change.

Iowa 217 begins in Breda and travels east to junction with US 71.
