**DISCUSSION/BACKGROUND:**

Transfer agreement number TJ-236-0 (2,3)--2M-14 between the Iowa Department of Transportation, Carroll County and the City of Templeton transferred Iowa 236 to County and City jurisdiction on April 3, 1987. The official description of Iowa 236 should be deleted from the Primary Road System to reflect this transfer.

Iowa 236 begins approximately one-half (½) mile south of Templeton and travels northerly and westerly into Templeton.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve deleting the description of Iowa 236 in Carroll County from the Primary Road System.

Old Description - Iowa 236 and its extension in Carroll County described as follows:

Beginning at the NE Corner of Section 20-T82N-R35W (junction Iowa 141 and US 71); thence north following substantially the section line through Section 16-T82N-R35W to the east corporation line of Templeton connecting with unnamed street.

Templeton:

Beginning at the east corporation line connecting with an unnamed street; thence northwest on unnamed street to 2nd Street; thence west on 2nd Street to Main Street; thence north on Main Street to Railway Street.

Beginning at a point approximately 400 feet east of the SW Corner of Section 16-T82N-R35W; thence curving in a northwesterly direction to a point approximately 400 feet north of the SW Corner of Section 16-T82N-R35W.
