TITLE: Official Description Change: Iowa 245, Marshall County

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number 89-TJ-007-64 between the Iowa Department of Transportation and Marshall County transferred the rural portion of Iowa 245 to county jurisdiction on December 26, 1989. Transfer of jurisdiction agreement number 91-TJ-007-64 between the Iowa Department of Transportation and the City of Rhodes transferred the remaining portion of Iowa 245 to city jurisdiction on December 28, 1990.

The official description of Iowa 245 and its extension in Marshall County should be deleted to reflect these transfers.

Iowa 245 begins in Rhodes and travels easterly approximately 1 ¼ miles to junction with Iowa 234.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the description of Iowa 245 and its extension in Marshall County from the Primary Road System.

Old Description – Iowa 245 and its extension in Marshall County described as follows:

Rhodes:

Beginning on Main Street at Linn Street; thence north on Main Street to Walnut Street; thence east and northeast on Walnut Street to the east corporation line.

Beginning on the east corporation line of Rhodes connecting with Walnut Street; thence in a northeasterly direction through Section 10-T82N-R20W to a point approximately 200 feet east of the W ¼ Corner of said Section 10; thence easterly following substantially the center of section line said Section 10 to a point near the center of Section 10-T82N-R20W, (junction Iowa 234).

It is recommended that the old description of Iowa 245 in Marshall County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 245 and its extension in Marshall County as follows:

Rhodes:

Beginning on an unnamed street at the north line of Linn Street; thence northerly, easterly, and northeasterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Rhodes connecting with an unnamed street; thence in a northeasterly direction through Section

10-T82N-R20W to a point approximately 200 feet east of the W $\frac{1}{4}$ Corner of said Section 10; thence easterly following substantially the center section line said Section 10 to a point near the center of Section 10-T82N-R20W.
