DISCUSSION/BACKGROUND:

Iowa 250 begins in the City of Lakota and travels northerly to US 169 approximately one-half mile north of the City of Lakota.

Transfer of jurisdiction agreement number TJ-250-0 (1)--2M-55, between the City of Lakota and the Iowa Department of Transportation transferred that portion of Iowa 250 from Smith Street north to the north corporation line of Lakota to city jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-250-0 (2)--2M-55, between Kossuth County and the Iowa Department of Transportation transferred that portion of Iowa 250 from the north corporation line of the City of Lakota north to US 169 to county jurisdiction on July 1, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 250 in Kossuth County from the primary road system.

Remove Iowa 250 and its extension in Kossuth County as follows:

Lakota:

Beginning on an unnamed street at Smith Street thence northerly to the north corporation, connecting with an unnamed street.

Beginning on the north corporation line of the City of Lakota, connecting with an unnamed street; thence north following substantially the east

quarter section line of Section 24–T99N–R28W to a point approximately 1281 feet west of the NE Corner of Section 24–T99N–R28W (junction US 169 and Iowa 9).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 250 in Kossuth County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 250 begins in Lakota and travels in a northerly direction terminating at the junction US 169 approximately ½ mile north.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 250 and its extension in Kossuth County, Iowa as follows:

Lakota:

Beginning on an unnamed street at Smith Street; thence northerly to the north corporation, connecting with an unnamed street.

Beginning on the north corporation line of the City of Lakota connecting with an unnamed street; thence north following substantially the east quarter section line of Section 24–T99N–R28W to a point approximately

1281 feet west of the NE Corner of Section 24-T99N-R28W (junction US 169 and Iowa 9).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 250, Kossuth County, Iowa.
