TITLE: Official Description Change: Iowa 262, Wright County

DISCUSSION/BACKGROUND:

Iowa 262 begins at a junction with US 69 approximately one mile west of the City of Galt and proceeds east to the City of Galt.

Transfer of jurisdiction agreement number TJ-262-0(1)--2M-99, between Wright County and the Iowa Department of Transportation, transferred that portion of Iowa 262 from a junction with US 69 approximately 475 feet south of the W ¼ Corner Section 13-T91N-R24W easterly to the west corporation line of the City of Galt to county jurisdiction on July 15, 1980.

Transfer of jurisdiction agreement number TJ-262-0(2)--2M-99, between the City of Galt and the Iowa Department of Transportation, transferred that portion of Iowa 262 from the west corporation line of the City of Galt southeasterly and northerly to Second Street to city jurisdiction on July 22, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 262 in Wright County from the primary road system.

Remove from the primary road system Iowa 262 and its extension in Wright County as follows:

Beginning at a point approximately 475 feet south of the W ¼ Corner Section 13-T91N-R24W; thence easterly following substantially the center section line of Sections 13 and 18-T91N-R24W to a point approximately 1,000 feet east of the W ¼ Corner Section 18-T91N-R23W; thence curving in a southeasterly direction through said Section 18 to the west corporation line of the City of Galt connecting with an unnamed street.

Galt:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly and northerly to Second Street.

DISCUSSION/BACKGROUND:

Iowa 262 begins at US 69 approximately 1 ½ miles west of Galt, and travels generally easterly to a point in Galt, Iowa.

Due to a review of our Primary Road System Records Iowa 252 in Wright County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 262 in Wright County be deleted and the new description be included in the Primary Road System effective upon the adoption of this resolution.

Iowa 262 and its extension in Wright County as follows:

Beginning at a point approximately 475 feet south of the W $\frac{1}{4}$ Corner Section 13-T91N-R24W; thence curving in a northeasterly direction to a point approximately 600 feet east of the W $\frac{1}{4}$ Corner Section 13-T91N-R24W; thence easterly following substantially the center section line of Sections 13 and 18-T91N-R24W to a point approximately 1000 feet east of the W $\frac{1}{4}$ Corner Section 18-T91N-R23W; thence curving in a southeasterly direction through said Section 18 to the west corporation line of the City of Galt connecting with an unnamed street.

Galt:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly and northerly to Second Street.
