DISCUSSION/BACKGROUND:

Iowa 264 begins at the Clay-Buena Vista County line approximately four miles southeast of the City of Peterson and proceeds north to a junction with Iowa 10 approximately four miles east of the City of Peterson.

Transfer of jurisdiction agreement number TJ-264-0 (3)--2M-21 between Clay County and the Iowa Department of Transportation, transferred that portion of Iowa 264 from the Clay-Buena Vista County line near the SW Corner Section 32-T94N-R37W north to a junction with Iowa 10 near the NW Corner Section 32-T94N-R37W to county jurisdiction on August 7, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 264 in Clay County from the primary road system.

Remove Iowa 264 in Clay County as follows:

Beginning on the Clay County-Buena Vista County line at a point near the SW Corner of Section 32-T94N-R37W, Clay County (NW Corner of Section 5-T93N-R37W, Buena Vista County); thence northerly following substantially the section line of said Section 32 to near the NW Corner of Section 32-T94N-R37W (junction Iowa 10).
