DISCUSSION/BACKGROUND:

Iowa 264 begins in the City of Linn Grove and proceeds northerly to the Buena Vista-Clay County line approximately one mile north of the City of Linn Grove.

The State Functional Classification Review Board hearing on July 21, 1980, between the Iowa Department of Transportation (transferring jurisdiction) and the City of Linn Grove (receiving jurisdiction), transferred that portion of Iowa 264 from approximately 684 feet south of Lynn Street northwesterly to the west corporation line of Linn Grove to city jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-264-0 (4)--2M-11, between Buena Vista County and the Iowa Department of Transportation, transferred that portion of Iowa 264 from the west corporation line of Linn Grove northerly to the Buena Vista-Clay County line near the NW Corner Section 5-T93N-R37W to county jurisdiction on August 7, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 264 in Buena Vista County from the primary road system.

Remove Iowa 264 and its extension in Buena Vista County as follows:

Linn Grove:

Beginning on an unnamed street approximately 684 feet south of Lynn Street; thence northwesterly to the west corporation line connecting with an unnamed street.

Beginning on the west corporation line of the City of Linn Grove connecting with an unnamed street; thence in a northerly direction through Section 5-T93N-R37W to the Buena Vista-Clay County line at a point near the NW Corner Section 5-T93N-R37W, Buena Vista County (SW Corner Section 32-T94N-R37W, Clay County).

Linn Grove:

Beginning on an unnamed street approximately 684 feet south of Lynn Street; thence northwesterly to the west corporation line connecting with an unnamed street.

Beginning on the west corporation line of the City of Linn Grove connecting with an unnamed street; thence in a northerly direction through Section 5-T93N-R37W to the Buena Vista-Clay County line at a point near the NW Corner

Clay County).
