DISCUSSION/BACKGROUND:

Iowa 266 begins at US 69 approximately one and one quarter miles west of the City of Weldon, and travels easterly and southerly into the City of Weldon.

Transfer of jurisdiction agreement number TJ-266-0 (1) between Clarke County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ-266-0 (2) between the City of Weldon and the Iowa Department of Transportation, transferred that portion of Iowa 266 on the Decatur-Clarke County line from the northwest corner of the City of Weldon east along the north corporation line of the City of Weldon to Main Street to local jurisdiction on October 27, 1980.

Transfer of jurisdiction agreement number TJ-266-0 (2) between the City of Weldon and the Iowa Department of Transportation transferred that portion of Iowa 266 in the City of Weldon from the north corporation line south on Main Street to Second Avenue south to city jurisdiction on October 13, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 266 in Decatur County from the primary road system and approve including the attached new description of Iowa 266 in the primary road system.

Locate Iowa 266 in Decatur County as follows:

Beginning on the Decatur-Clarke County line (junction US 69) at a point near the NW Corner Section 5-T70N-R25W, Decatur County (SW Corner Section 32-T71N-R25W, Clarke County); thence east along the Decatur-Clarke County line following substantially the section line of Sections 5 and 4-T70N-R25W to the northwest corner of the City of Weldon connecting with an unnamed street.
