TITLE: Iowa 274, Kossuth County

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number TJ-274-0 (1) --2M-055 between the Iowa Department of Transportation and Kossuth County transferred Iowa 274 to County Jurisdiction on July 1, 1986. To reflect this transfer of jurisdiction the official description of Iowa 274 should be deleted from the Primary Road System.

Iowa 274 begins at the entrance to Ambrose A Call State Park approximately 1 ¼ miles southwest of Algona and travels south and east to a junction with US 169 approximately 1 ½ miles south of Algona.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 274 in Kossuth County from the Primary Road System.

Old Description – Iowa 274 in Kossuth County described as follows:

Beginning at the entrance to Ambrose A Call State Park at a point in the SW ¼ Section 11-T95N-R29W; thence in a generally southerly direction through Sections 11 and 14-T95N-R29W to a point near the N ¼ Corner NW ¼ Section 23-T95N-R29W; thence easterly following substantially the section line Section 23-T95N-R29W to a point near the NE Corner said Section 23 (junction US 169).
