DISCUSSION/BACKGROUND:

Iowa 278 begins in the City of Rathbun and proceeds southeasterly to Iowa 5 approximately two and one-half miles north of the City of Centerville.

Transfer of jurisdiction agreement number TJ-278-0 (6)--2M-4, between the City of Rathbun and the Iowa Department of Transportation, transferred that portion of Iowa 278 from Main Street southerly to the south corporation line to city jurisdiction on January 12, 1981.

Transfer of jurisdiction agreement number TJ-000-0 (1)--2M-4, between Appanoose County and the Iowa Department of Transportation, transferred that portion of Iowa 278 from the south corporation line of the City of Rathbun southeasterly to Iowa 5 near the S $\frac{1}{4}$ Corner Section 7-T69N-R17W to county jurisdiction on August 21, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 278 in Appanoose County from the primary road system.

Remove Iowa 278 and its extension in Appanoose County as follows:

Rathbun:

Beginning on an unnamed street at Main Street; thence southerly to the south corporation line connecting with an unnamed street.

Beginning on the south corporation line of the City of Rathbun connecting with an unnamed street; thence in a southeasterly direction through Sections 11 and 12-T69N-R18W and Section 7-T69N-R17W to a point approximately 50 feet north of the S ¼ Corner Section 7-T69N-R17W (junction Iowa 5).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records Iowa 273 in Appanoose County should be deleted and the new description added should be officially included into the Primary System.

Iowa 278 begins in Rathbun and travels generally southeasterly approximately 2 miles to a junction with Iowa 5.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 278 and its extension in Appanoose County as follows:

Rathbun:

Beginning on an unnamed street at Main Street; thence southerly to the south corporation line connecting with an unnamed street.

Beginning on the south corporation line of the City of Rathbun connecting with an unnamed street; thence in a southeasterly direction through Sections 11 and 12-T69N-R18W and Section 7-T69N-R17W to a point approximately 50 feet north of the S ¼ Corner Section 7-T69N-R17W (junction Iowa 5).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 278 in Appanoose County, Iowa.
