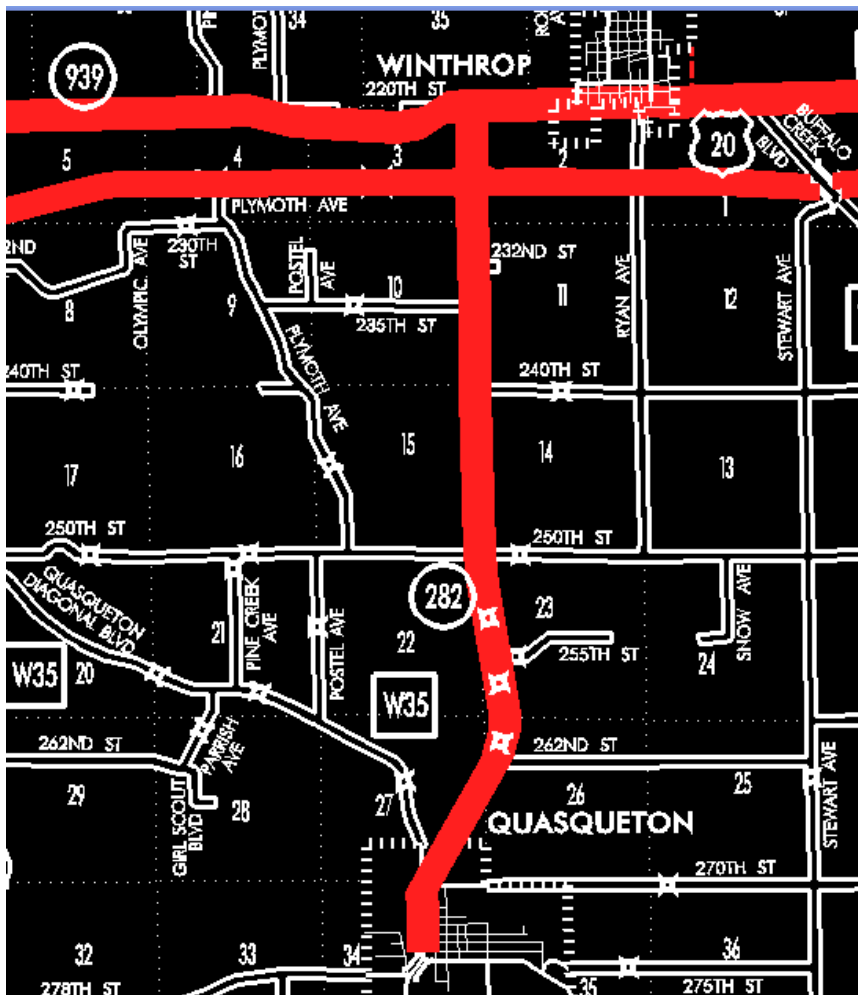

New Description – Iowa 282 and its extensions in Buchanan County described as follows:

Quasqueton:

Beginning at the south line of the intersection of Water Street and Cedar Street; thence north on Water Street to an unnamed street; thence northeast on an unnamed street to the north corporation line.

Beginning at the north corporation line of Quasqueton connecting with an unnamed street; thence in a northeasterly, northerly and northwesterly direction through Sections 27, 26, 23-T88N-R8W to a point approximately $\frac{1}{4}$ mile south of the NW Corner of Section 23 T88N-R8W; thence north following substantially the section line of Sections 23, 14, 11, and 2-T88N-R8W (junction US 20) to a point near the NW Corner of Section 2-T88N-R8W (junction Unsigned Iowa 939).
