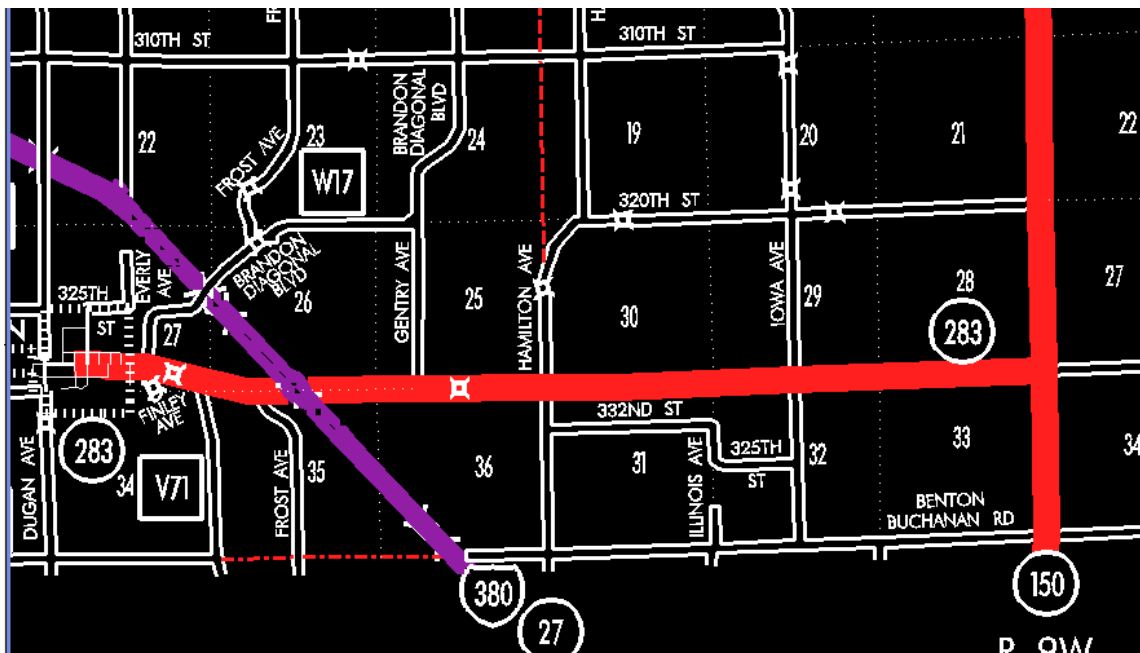

Beginning at the east corporation line of Brandon connecting with Main Street; thence east and southeast through Sections 27 and 26 to a point approximately $\frac{1}{4}$ mile west of the S $\frac{1}{4}$ Corner Section 26–T87N–R10W; thence east following substantially the section line of Sections 35 and 36–T87N–R10W continuing east along section line of Sections 31, 32, and 33–T87N–R9W to a point near the NE Corner of Section 33–T87N–R9W (junction Iowa 150).
