Iowa 284 begins in the City of Aurora and proceeds south and east to a junction with Iowa 187 at Lamont.

Transfer of jurisdiction agreement number TJ-284-0 (4)--2M-10, between the City of Aurora and the Iowa Department of Transportation, transferred that portion of Iowa 284 beginning at Warren Street; thence south, east and south to the south corporation line of Aurora to city jurisdiction on August 1, 1980.

Transfer of jurisdiction agreement number TJ-284- (3)--2M-10, between Buchanan County and the Iowa Department of Transportation transferred that portion of Iowa 284 from the south corporation line of Aurora south and east to a junction with Iowa 187 near the NE Corner Section 22--T90N-R7W to county jurisdiction on June 30, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 284 in Buchanan County from the primary road system.

Remove Iowa 284 and its extension in Buchanan County as follows:

Aurora:

Beginning at point 200 feet north of Warren Street; thence southerly, easterly, and southerly to the south corporation line of Aurora connecting with an unnamed street.

Beginning at the south corporation line of Aurora connecting with an unnamed street; thence south following substantially the section line of Section 18-T90N-R7W to a point near the NW Corner of Section 19-T90N-R7W; thence east following substantially the section line of Sections 19, 20, 21, and 22-T90N-R7W to a point near the NE Corner of Section 22-T90N-R7W (intersection of Iowa 187).
