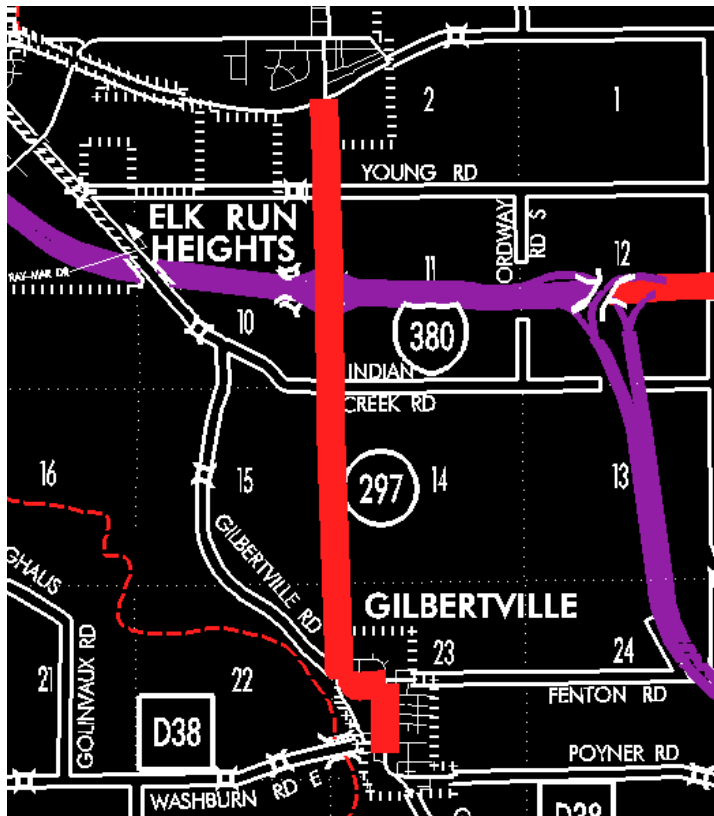

Gilbertville:

Beginning at the intersection of 13th Avenue and 5th Street; thence north on 5th Street to 20th Avenue; thence westerly and northerly on 20th Avenue to the north corporation line.

Beginning on the north corporation line of Gilbertville connecting with 20th Avenue; thence north following substantially the section line through Section 23, 14 and 11-T88N-R12W to the south corporation line of Raymond connecting with 3rd Street.

Raymond:

Beginning on the south corporation line connecting with 3rd Street (US 20); thence north approximately 1200 feet.

Raymond:

Beginning on the south corporation line connecting with an unnamed street; thence northerly 1200 feet.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 297 in Black Hawk County, Iowa.
