DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records Iowa 300 in Harrison County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 300 in Harrison County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 300 and its extension in Harrison County as follows;

Modale:

Beginning on an unnamed street at the east line of Main Street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning at the east corporation line of the City of Modale, connecting with an unnamed street; thence east through Section 29-T79N-R44W junction Interstate 29 to a point approximately 700 feet north and 400 feet west of the SE Corner Section 29-T79N-R44W (east ramps of Interstate 29).
