

New Description – Iowa 301 and its extension in Harrison County described as follows:

Beginning at a point approximately 1,800 feet south and 500 feet east of the NW Corner Section 26–T81N–R45W (west ramps of Interstate 29); thence northeasterly through said Section 26 (junction Interstate 29) to a point approximately 1,000 feet east of the N ¼ Corner Section 26–T81N–R45W; thence easterly following substantially the section line said Section 26 to the west corporation line of Little Sioux, connecting with Vine Street.

Little Sioux:

Beginning on Vine Street at the west corporation line; thence northeast and east on Vine Street to 2nd Street; thence north on 2nd Street to Mulberry Street; thence east on Mulberry Street to 3rd Street.

Due to a review of our Primary Road System Records Iowa 301 in Harrison County should be deleted and the new description added should be officially included into the Primary System.

It is recommended that the old description of Iowa 301 in Harrison County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Beginning at a point approximately 1800 feet south and 500 feet east of the NW Corner Section 26-T81N-R45W (west ramps of Interstate 29); thence northeasterly through said Section 26 (junction Interstate 29) to a point approximately 1000 feet east of the N  $\frac{1}{4}$  Corner Section 26-T81N-R45W; thence easterly following substantially the section line said Section 26 to the west corporation line of the City of Little Sioux, connecting with an unnamed street.

Little Sioux:

Beginning on the west corporation line connecting with an unnamed street; thence northeasterly, easterly, northerly and easterly to Third Street.
