**TITLE:** Official Description Change: Iowa 312, Mitchell County

**DISCUSSION/BACKGROUND:**

Iowa 312 begins at the junction of Iowa 9 approximately one and one-half miles west of Riceville, and travels northerly terminating in McIntire, Iowa.

Due to transfer of jurisdiction agreement number TJ-312-0 (1) --2M-66 between Mitchell County and the Iowa Department of Transportation approved May 2, 1980, that portion of Iowa 312 from Iowa 9 near the center Section 26-T99N-R15W northwesterly and northerly to the south corporation line of the City of McIntire near the NW Corner Section 2-T99N-R15W should be deleted from the primary road system and reverted to the Mitchell County secondary road system effective July 1, 1980.

Due to transfer of jurisdiction agreement number TJ-312-0 (2) --2M-66 between the City of McIntire and the Iowa Department of Transportation approved May 29, 1980, that portion of Iowa 312 from the south corporation line of McIntire northerly and westerly to the east line of Third Street should be deleted from the primary road system and reverted to the City street system of McIntire effective July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the description of Iowa 312 in Mitchell County, as referred to in the attached detailed description, be deleted from the primary road system.

Remove Iowa 312 and its extension in Mitchell County as follows:

Beginning at a point near the center of Section 26-T99N-R15W (junction of Iowa 9); thence in a westerly and northwesterly direction through Section 26-T99N-R15W to a point approximately 500 feet north of the W  $\frac{1}{4}$  Corner of Section 26-T99N-R15W; thence northerly following substantially the section line of Sections 26, 23, 14, 11, and 2-T99N-R15W to the south corporation line of the City of McIntire, connecting with an unnamed street.

McIntire:

Beginning on the south corporation line connecting with an unnamed street; thence northerly and westerly to the east line of Third Street, connecting with an unnamed street.

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 312 in Mitchell County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 312 begins at the junction of Iowa 9 approximately 13 miles west of Riceville, Iowa and travels westerly and northerly terminating in McIntire, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 312 and its extension in Mitchell County as follows:

Beginning at a point near the center of Section 26-T99N-R15W (junction of Iowa 9); thence in a westerly and northwesterly direction through Section 26-T99N-R15W to a point approximately 500 feet north of the W ¼ Corner of Section 26-T99N-R15W; thence northerly following substantially the section line of Sections 26, 23, 14, 11, and 2-T99N-R15W to the south corporation line of the City of McIntire, connecting with an unnamed street.

McIntire:

Beginning on the south corporation line, connecting with an unnamed street; thence northerly and westerly to the east line of Third Street, connecting with an unnamed street.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 312 in Mitchell County, Iowa.
