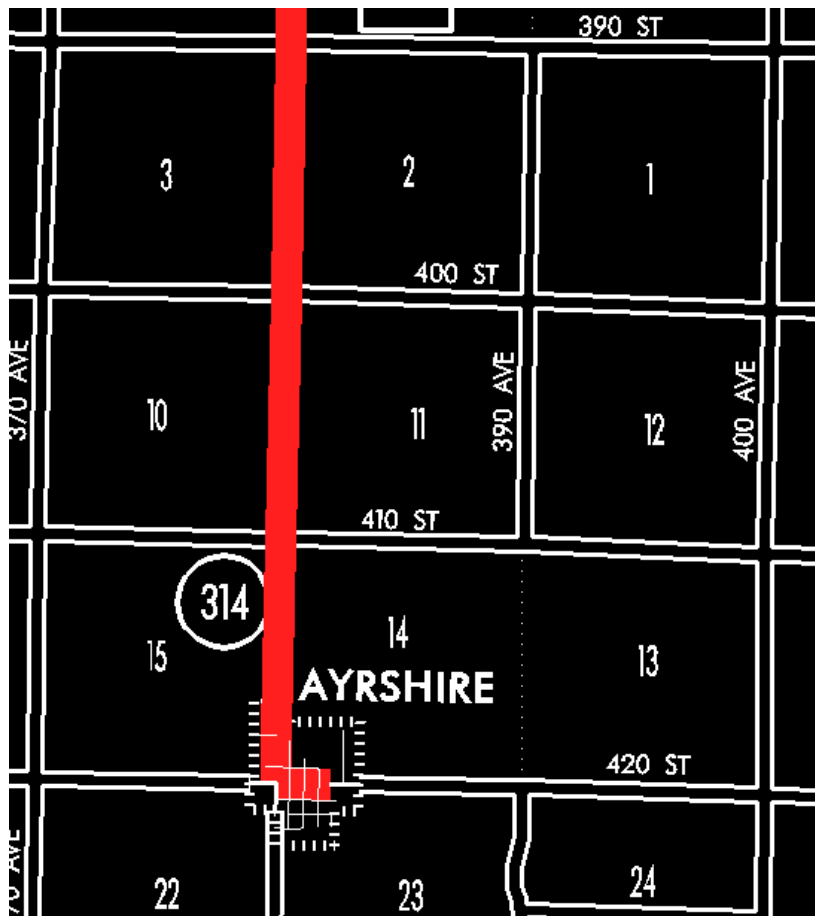
DISCUSSION/BACKGROUND:

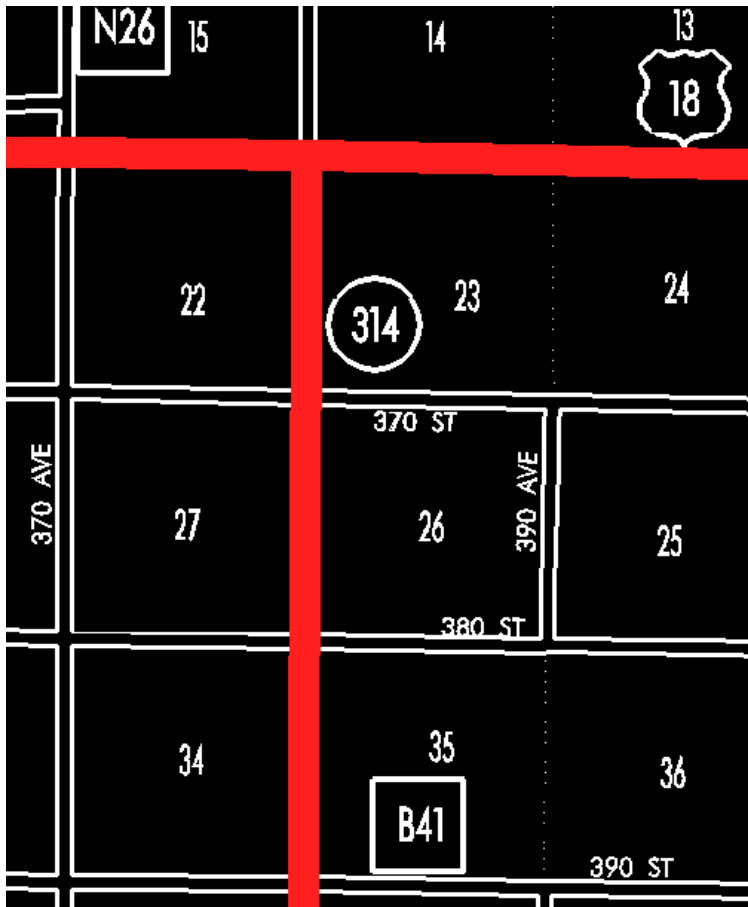
Transfer of jurisdiction agreement number TJ-314-0(4) (2003-TJ-028), between the city of Ayrshire and the Iowa Department of Transportation, transferred that portion of Iowa 314 from Silver Lake Avenue at a point approximately 320 feet east of Campbell Street; thence west on Silver Lake Avenue to Doon Street; thence north on Doon Street approximately 1080 feet to the north corporation line to city jurisdiction on April 16, 2003.

Transfer of jurisdiction agreement number TJ-314-0(3) (2003-TJ-027), between Palo Alto County and the Iowa Department of Transportation, transferred that portion of Iowa 314 from the north corporation line of Ayrshire connecting with Doon Street; thence northerly following substantially the section line of Sections 14, 11, and 2-T95N-R34W and Sections 35, 26, and 23-T96N-R34W to a point (junction US 18) near the NW Corner Section 23-T96N-R34W to county jurisdiction on April 16, 2003.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 314 and its extensions in Palo Alto County from the Primary Road System.

New Description – Iowa 314 and its extension in Palo Alto County described as follows:

Ayrshire:

Beginning on Silver Lake Avenue at a point approximately 320 feet east of Campbell Street; thence west on Silver Lake Avenue to Doon Street;

thence north on Doon Street approximately 1,080 feet to the north corporation line.

Beginning again on the north corporation line of Ayrshire and connecting with Doon Street; thence northerly following substantially the section line of Sections 14, 11 and 2-T95N-R34W and 35, 26 and 23-T96N-R34W to a point (junction US 18) near the NW Corner Section 23-T96N-R34W.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records, Iowa 314 in Palo Alto County should be deleted and the new description added should be officially included into the Primary System.

Iowa 314 begins in Ayrshire, and travels westerly and northerly to a junction with US 18 approximately 6 miles north of Ayrshire, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 314 and its extension in Palo Alto County as follows:

Ayrshire:

Beginning at a point on an unnamed street approximately 320 feet east of Campbell Street; thence westerly and northerly to the north corporation line and connecting with an unnamed street.

Beginning again on the north corporation line of the City of Ayrshire and connecting with an unnamed street; thence northerly following substantially the section line of Sections 14, 11 and 2-T93N-R34W and 33, 26 and 23-T96N-R34W to a point (junction US 13) near the NW Corner Section 23-T96N-R34W.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 314 in Palo Alto County, Iowa.
