**TITLE:** Official Description Change: Iowa 317, Story County

**DISCUSSION/BACKGROUND:**

Iowa 317 begins at US 65 approximately one-quarter mile west of the City of Zearing, and travels easterly into the City of Zearing.

Transfer of jurisdiction agreement number TJ-317-0(2), between Story County and the Iowa Department of Transportation, transferred that portion of Iowa 317 from US 65 approximately 1,250 feet south of the NW Corner Section 21-T85N-R21W easterly to the west corporation line of the City of Zearing to County jurisdiction on August 25, 1980. The remaining portion of Iowa 317 in the City of Zearing should be re-designated unsigned Iowa 947.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the present description of Iowa 317 in Story County from the primary road system.

Remove Iowa 317 and its extension in Story County as follows:

Beginning at a point approximately 1250 feet south of the NW Corner Section 21-T85N-R21W (junction US 65); thence easterly through Section 21-T85N-R21W to the west corporation line of the City of Zearing connecting with an unnamed street.

Zearing:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly and easterly to Pearl Street.

**DISCUSSION/BACKGROUND:**

Iowa 317 begins at US 65 approximately  $\frac{3}{4}$  mile west of Zearing, and travels generally easterly to a point in Zearing, Iowa.

Due to a review of our Primary Road System Records Iowa 317 in Story County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

it is recommended that the old description of Iowa 317 in Story County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 317 and its extension in Story County as follows:

Beginning at a point approximately 1250 feet south of the NW Corner Section 21-T85N-R21W (junction US 65); thence easterly through Section 21-T85N-R21W to the west corporation line of the City of Zearing connecting with an unnamed street.

Zearing:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly and easterly to Pearl Street.
