TITLE: Official Description Change: Iowa 323, Wright County

DISCUSSION/BACKGROUND:

Iowa 323 begins at Iowa 17 approximately three miles west of the City of Woolstock, and proceeds easterly and southerly into the City of Woolstock.

Transfer of jurisdiction agreement number TJ-323-0(2)--2M-99, between Wright County and the Iowa Department of Transportation, transferred that portion of Iowa 323 from Iowa 17 easterly to the City of Woolstock to county jurisdiction on July 15, 1980.

Transfer of jurisdiction agreement number TJ-323-0(2)--2M-99 between Wright County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ-323-0(3)--2M-99 between the City of Woolstock and the Iowa Department of Transportation, transferred that portion of Iowa 323 from the northwest corner of the City of Woolstock easterly approximately 0.32 mile along the north corporation line of Woolstock to local jurisdiction on July 22, 1980.

Transfer of jurisdiction agreement number TJ-323-0(3)--2M-99, between the City of Woolstock and the Iowa Department of Transportation, transferred that portion of Iowa 323 from the north corporation line of Woolstock southeasterly and southerly to Hernando Street to city jurisdiction on July 22, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 323 in Wright County from the primary road system.

Remove from the primary road system Iowa 323 and its extension in Wright County as follows:

Beginning at a point near the NW Corner Section 34-T90N-R26W (junction Iowa 17); thence easterly following substantially the section line of Sections 34, 35, and 36-T90N-R26W to the west corporation line of the City of Woolstock connecting with an unnamed street.

Woolstock:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and southerly to Hernando Street.

DISCUSSION/BACKGROUND:

Iowa 323 begins at Iowa 17, approximately 3 miles west and ½ mile north of Woolstock, and travels easterly and southerly to a point in Woolstock, Iowa.

Due to a review of our Primary Road System Records Iowa 323 in Wright County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 323 in Wright County be deleted and the new description be included in the Primary Road System effective upon the adoption of this resolution.

Iowa 323 and its extension in Wright County as follows:

Beginning at a point near the NW Corner Section 34-T90N-R26W (junction Iowa 17); thence easterly following substantially the section line of Sections 34, 35, and 36-T90NR26W to the west corporation line of the City of Woolstock connecting with an unnamed street.

Woolstock:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and southeasterly to Hernando Street.

Beginning at the intersection of Alice Street and Hernando Street; thence north and west on Alice Street to the west corporation line.
