Iowa 329 begins at a junction with US 169 on the south edge of the City of Boxholm and proceeds easterly to the City of Pilot Mound.

Transfer of jurisdiction agreement number TJ-329-0 (4) --2M-08 between Boone County and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-329-0 (3) --2M-08 between the City of Boxholm and the Iowa Department of Transportation, transferred that portion of Iowa 329 from a junction with US 169 east along the south corporation line of the City of Boxholm to local jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-329-0 (4) --2M-08, between Boone County and the Iowa Department of Transportation, transferred that portion of Iowa 329 from the east corporation line of the City of Boxholm easterly to the west corporation line of the City of Pilot Mound to county jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-329-0 (4) --2M-08 between Boone County and the Iowa Department of Transportation and transfer of agreement number TJ-329-0 (2) --2M-08 between the City of Pilot Mound and the Iowa Department of Transportation, transferred that portion of Iowa 329 from the west corporation line of the City of Pilot Mound east along the north corporation line to a point near the N  $\frac{1}{4}$  Corner Section 20-T85N-R27W to local jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-329-0 (2) --2M-08, between the City of Pilot Mound and the Iowa Department of

Transportation, transferred that portion of Iowa 329 on Pilot Street from the north corporation line to First Street to city jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 329 in Boone County from the primary road system.

Remove Iowa 329 and its extension in Boone County as follows:

Beginning at a point near the NW Corner of Section 22-T85N-R28W; thence east following substantially the section line of Sections 22, 23, 24-T85N-R28W continuing east following substantially the section line of Section 19-T85N-R27W to a point on the north corporation line of the City of Pilot Mound connecting with an unnamed street.

Pilot Mound:

Beginning at the east corporation line of Pilot Mound connecting with an unnamed street; thence southerly to First Street.
