Iowa 334 begins at US 63 approximately one and one-half miles southwest of the City of Frederika and travels easterly and northerly into the City of Frederika.

Due to a transfer of jurisdiction agreement number TJ-334-0 (2) --2M-09) between Bremer County and the Iowa Department of Transportation, that portion of Iowa 334 from US 63 easterly and northerly to the south corporation line of the City of Frederika approximately 500 feet north of the S ¼ Corner Section 7-T93N-R12W was transferred to county jurisdiction effective July 1, 1980.

Due to a transfer of jurisdiction agreement number TJ-334-0 (2) --2M-09) between Bremer County and the Iowa Department of Transportation, and a transfer of jurisdiction agreement number TJ-334-0 (3)--2M-09) between the City of Frederika and the Iowa Department of Transportation, that portion of Iowa 334 along the corporation line of the City of Frederika from approximately 500 feet north of the S ¼ Corner Section 7-T93N-R12W northerly approximately 700 feet was transferred to local jurisdiction effective July 1, 1980.

Due to a transfer of jurisdiction agreement number TJ-334-0 (3) --2M-09) between the City of Frederika and the Iowa Department of Transportation, that portion of Iowa 334 from the south corporation line approximately 1,200 feet north of the S ¼ Corner Sec.7-T93N-R12W north and east to First Ave. was transferred to city jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 334 in Bremer County, as attached, be deleted from the primary road system.

Remove Iowa 334 and its extension in Bremer County as follows:

Beginning at a point near the S.W. Corner Section 12-T93N-R13W (junction US 63); thence easterly following substantially the section line of Section 13-T93N-R13W and Section 18-T93N-R12W to a point approximately 400 feet west of the N  $\frac{1}{4}$  Corner Section 18-T93N-R12W; thence curving northeasterly through Section 7-T93N-R12W to a point approximately 400 feet north of the S  $\frac{1}{4}$  Corner of said Section 7; thence northerly through Section 7-T93N-R12W to the south corporation line of the City of Frederika connecting with an unnamed street.

Frederika:

Beginning at the south corporation line connecting with an unnamed street; thence northerly and easterly to the east line of First Avenue.

#### **DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System Records, Iowa 334 in Bremer County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 334 in Bremer County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 334 and its extension in Bremer County as follows:

Beginning at a point near the SW Corner Section 12-T93N-R13W (junction US 63); thence easterly following substantially the section line of Section 13-T93N-R13W and Section 18-T93N-R12W to a point approximately 400 feet west of the N  $\frac{1}{4}$  Corner Section 18-T93N-R12W; thence curving northeasterly through Section 7-T93N-R12W to a point approximately 400 feet north of the S  $\frac{1}{4}$  Corner of said Section 7; thence northerly through Section 7-T93N-R12W to the south corporation line of the City of Frederika connecting with an unnamed street.

Frederika:

Beginning at the south corporation line connecting with an unnamed street; thence northerly and easterly to the east line of 1st Avenue.

thence north approximately 469 feet to Third Street; thence east on Third Street approximately 382 feet to the east line of an unnamed street.
