**DISCUSSION/BACKGROUND:**

Iowa 336 begins at a junction with Iowa 150 approximately six miles south of the City of Independence and proceeds east into the City of Rowley.

Transfer of jurisdiction agreement number TJ-336-0 (2)--2M-10, between Buchanan County and the Iowa Department of Transportation, transferred that portion of Iowa 336 from a junction with Iowa 150 near the NW Corner Section 10-T87N-R9W east to the west corporation line of the City of Rowley to county jurisdiction on June 30, 1980.

Transfer of jurisdiction agreement number TJ-336-0 (3)--2M-10, between the City of Rowley and the Iowa Department of Transportation, transferred that portion of Iowa 336 from the west corporation line east, south and east to Johnson Street to city jurisdiction on August 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 336 in Buchanan County from the primary road system.
