DISCUSSION/BACKGROUND:

Iowa 343 begins at Iowa 333 approximately one-half mile south of the City of Northboro and travels northeasterly into the City of Northboro.

A construction agreement, between Page County and the Iowa Department of Transportation, transferred that portion of Iowa 343 from Iowa 333 approximately 630 feet west of the SE Corner Section 22-T67N-R39W northeasterly to the south corporation line of the City of Northboro to county jurisdiction on December 15, 1980.

An agreement, between the City of Northboro and the Iowa Department of Transportation, transferred that portion of Iowa 343 from the south corporation line northeasterly and easterly to First Street to city jurisdiction on December 15, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 343 in Page County from the primary road system.

Remove Iowa 343 and its extension in Page County as follows:

Beginning at a point approximately 630 feet west of the SE Corner Section 22-T67N-R39W; thence in northeasterly direction through Sections 22 and 23-T67N-R39W to the south corporation line of the City of Northboro, connecting with an unnamed street.

Northboro:

Beginning on the south corporation line of the City of Northboro connecting with an unnamed street; thence northeasterly and easterly on unnamed street to First Street.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records, Iowa 343 in Page County should be deleted and the new description added should be officially included into the Primary System.

Iowa 343 begins at a Junction with Iowa 333 approximately 1 mile southwest of the City of Northboro and travels northeasterly to a point in the City of Northboro, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 343 and its extension in Page County as follows:

Beginning at a point approximately 630 feet west of the SE Corner Section 22-T67N-R39W; thence in a northeasterly direction through Sections 22 and 23-T67N-R39W to the south corporation line of the City of Northboro, connecting with an unnamed street.

Northboro:

Beginning on the south corporation line of the City of Northboro connecting with an unnamed street; thence northeasterly and easterly on unnamed street to First Street.
