Transfer of jurisdiction agreement number 2001-TJ-007, between Ringgold County and the Iowa Department of Transportation, transferred that portion of Iowa 344 from a point near the SW Corner Section 30-T69N-R29W; thence easterly following substantially the section line of Section 31-T69N-R29W to a point approximately 900 feet west of the SE Corner Section 30-T69N-R29W; thence curving northeasterly through Section 30-T69N-R29W to a point approximately 630 feet north of the SE Corner Section 30-T69N-R29W (junction US 169) to county jurisdiction on November 12, 2001.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 344 and its extensions in Ringgold County from the Primary Road System.

Due to a review of our Primary Road System records, Iowa 344 in Ringgold County should be deleted and the new description added should be officially included into the Primary System.

Iowa 344 begins at the State Fish Hatchery approximately 1 mile north of Mount Ayr and travels easterly and northeasterly approximately 1 mile to US 169.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 344 in Ringgold County as follows:

Beginning at a point near the SW Corner Section 30-T69N-R29W; thence easterly following substantially the section line of Section 31-T69N-R29W to a point approximately 900 feet west of the SE Corner Section 30-T69N-R29W; thence curving northeasterly through Section 30-T69N-R29W to a point approximately 630 feet north of the SE Corner Section 30-T69N-R29W (junction US 169).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 344 in Ringgold County, Iowa.
