**DISCUSSION/BACKGROUND:**

Iowa 353 begins in the City of Rowan, and travels northerly to Iowa approximately 250 feet north of the City of Rowan.

Transfer of jurisdiction agreement number TJ-353-0(2)--2M-99, between the City of Rowan and the Iowa Department of Transportation, transferred that portion of Iowa 353 from Main Street northerly to the north corporation line of Rowan to city jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-353-0(1)--2M-99, between Wright County and the Iowa Department of Transportation, transferred that portion of Iowa 353 from the north corporate limits of the City of Rowan northerly to Iowa 3 to county jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 353 in Wright County from the primary road system.

Remove from the primary road system Iowa 353 and its extension in Wright County as follows:

Rowan:

Beginning on an unnamed street at Main Street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Rowan connecting with an unnamed street; thence northerly through Section 34-T92N-R23W to a point approximately 1300 feet east of the NW Corner Section 34-T92N-R23W (junction Iowa 3).

Due to a review of our Primary Road System Records Iowa 353 in Wright County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 353 in Wright County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Iowa 353 and its extension in Wright County as follows:

Rowan:

Beginning on an unnamed street at Main Street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Rowan connecting with an unnamed street; thence northerly through Section 34-T92N-R23W to a point approximately 1300 feet east of the NW Corner Section 34-T92N-R23W (junction Iowa 3).
