DISCUSSION/BACKGROUND:

Iowa 367 begins in the City of Rutland and proceeds easterly to a junction with US 169 approximately one and one-half miles north of the City of Humboldt.

Transfer of jurisdiction agreement number TJ-367-0 (1)--2M-46, between the City of Rutland and the Iowa Department of Transportation, transferred that portion of Iowa 367 from Elm Avenue easterly to the east corporation line of Rutland to city jurisdiction on July 15, 1980.

Transfer of jurisdiction agreement number TJ-367-0 (2)--2M-46, between Humboldt County and the Iowa Department of Transportation, transferred that portion of Iowa 367 from the east corporation line of the City of Rutland easterly to a junction with US 169 near the NE Corner Section 26-T92N-R29W to county jurisdiction on July 1, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 367 in Humboldt County from the primary road system.

Remove Iowa 367 and its extension in Humboldt County as follows:

Rutland:

Beginning on the west line of Elm Avenue, connecting with an unnamed street; thence easterly to the east corporation line, connecting with an unnamed street.

Beginning on the east corporation line of the City of Rutland, connecting with an unnamed street; thence easterly following substantially the section line of Sections 28, 27, and 26–T92N–R29W to a point near the NE Corner Section 26–T92N–R29W (junction of US 169).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records Iowa 367 in Humboldt County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 367 begins in Rutland and travels easterly terminating at junction US 169 approximately 1½ miles north of Humboldt, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 367 and its extensions in Humboldt County as follows:

Rutland:

Beginning on the west line of Elm Avenue, connecting with an unnamed street; thence easterly to the east corporation line, connecting with an unnamed street.

Beginning on the east corporation line of the City of Rutland, connecting with an unnamed street; thence easterly following substantially the section line of Sections 28, 27, and 26-T92N-R29W to a point near the NE Corner Section 26-T92N-R29W (junction of US 169).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 367 in Humboldt County, Iowa.
