**TITLE:** Unsigned Iowa 374 in Jasper County

**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number 2000-TJ-005, between Jasper County and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 374 from a point near the N  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  of Section 23-T78N-R20W (west termini of the Iowa 163 interchange northwest of Monroe) southeast through Sections 23, 24, and 25-T78N-R20W to the north corporation line of Monroe (W  $\frac{1}{4}$  Corner SE  $\frac{1}{4}$  of Section 25-T78N-R20W) connecting with Business 163 to county jurisdiction on July 18, 2000.

Transfer of jurisdiction agreement number 2000-TJ-004, between the City of Monroe and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 374 from the north corporation line (W  $\frac{1}{4}$  Corner SE  $\frac{1}{4}$  of Section 25-T78N-R20W) connecting with Business 163; thence southeast following Business 163 to the east corporation line (approximately 500 feet south of Center Section 31-T78N-R19W) to city jurisdiction on February 21, 2000.

Transfer of jurisdiction agreement number 2000-TJ-005, between Jasper County and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 374 from the east corporation line of the City of Monroe (approximately 500 feet south of the Center Section 31-T78N-R19W) connecting with Business 163; thence southeast approximately 630 feet to county jurisdiction on July 18, 2000.

**Proposal/Action Recommendation:**

It is recommended to approve deleting the present description of Unsigned Iowa 374 and its extensions in Jasper County from the Primary Road System.

**DISCUSSION/BACKGROUND:**

New Description – Unsigned Iowa 374 in Jasper County described as follows:

Beginning near the N  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  of Section 23-T78N-R20W (west termini of the Iowa 163 interchange northwest of Monroe) southeast through Sections 23, 24, and 25-T78N-R20W to the north corporation line of Monroe (W  $\frac{1}{4}$  Corner SE  $\frac{1}{4}$  of Section 25-T78N-R20W) connecting with Business 163.

Monroe:

Beginning on the north corporation line (W  $\frac{1}{4}$  Corner SE  $\frac{1}{4}$  of Section 25-T78N-R20W) connecting with Business 163; thence southeast following Business 163 to the east corporation line (approximately 500 feet south of Center Section 31-TT78N-R19W).

Beginning again on the east corporation line of Monroe (approximately 500 feet south of Center Section 31–TT78N–R19W) connecting with Business 163; thence southeast approximately 630 feet.

**Proposal/Action Recommendation:**

It is recommended to approve adding the description of unsigned Iowa 374 in Jasper County to the Primary Road System.
