DISCUSSION/BACKGROUND:

Iowa 387 begins at the Davenport Municipal Airport at a point approximately 100 feet west of the N ¼ Corner Section 35-T79N-R3E and extends easterly to the junction of US 61.

Approval of this order is necessary for completion of action for reversion of Iowa 387 to the Scott County secondary road system. This is in accordance with an agreement between Scott County and the Iowa DOT executed by the state on March 12, 1975.

PROPOSAL/ACTION RECOMMENDATION:

Request for authorization to delete Iowa 387 in Scott County from the primary road system.

Remove Iowa 387 in Scott County as follows:

Beginning at the Davenport Municipal Airport at a point approximately 100 feet west of the N ¼ Corner Section 35-T79N-R3E; thence easterly following substantially the section line of Sections 35 and 36-T79N-R3E to a point approximately 100 feet east of the SW Corner Section 25-T79N-R3E (junction US 61).

DISCUSSION/BACKGROUND:

Iowa 387 begins at the Davenport Municipal Airport and travels easterly approximately ½ mile to US 61.

Due to a review of our Primary Road System Records Iowa 387 in Scott County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 387 in Scott County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 387 in Scott County as follows:

Beginning at the Davenport Municipal Airport at a point approximately 100 feet west of the N $\frac{1}{4}$ Corner Section 35-T79N-R3E; thence easterly following substantially the section line of Sections 35 and 36-T79N-R3E to a point approximately 100 feet east of the SW Corner Section 25-T79N-R3E (junction US 61).
