TITLE: Official Description Change: Iowa 388, O'Brien County

DISCUSSION/BACKGROUND:

Iowa 388 begins in the City of Calumet and proceeds east approximately ½ mile to US 59.

Transfer of jurisdiction agreement number TJ-388-0(3)--2M-71, between the City of Calumet and the Iowa Department of Transportation, transferred that portion of Iowa 388 from Morse Street easterly to the east corporation line to city jurisdiction on November 13, 1980.

Transfer of jurisdiction agreement number TJ-388-0(3)--2M-71, between the City of Calumet and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-388-0(2)--2M-71, between O'Brien County and the Iowa Department of Transportation, transferred that portion of Iowa 388 from the east corporation line of the City of Calumet easterly along the south corporation line of the City of Calumet to the east corporation line of Calumet to local jurisdiction on November 13, 1980.

Transfer of jurisdiction agreement number TJ-388-0(2)--2M-71, between O'Brien County and the Iowa Department of Transportation, transferred that portion of Iowa 388 from the east corporation line of the City of Calumet easterly to US 59 near the E ¼ Corner Section 22-T94N-R40W to county jurisdiction on July 1, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 388 in O'Brien County from the primary road system.

Remove Iowa 388 and its extension in O'Brien County as follows:

Calumet:

Beginning at Morse Street connecting with an unnamed street; thence easterly on said unnamed street to the east corporation line, connecting with an unnamed street.

Beginning again on the east corporation line of the City of Calumet connecting with an unnamed street; thence easterly following substantially the center section line of Section 22-T94N-R40W to a point (junction US 59) near the E ¼ Corner Section 22-T94N-R40W, O'Brien County.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 388 in O'Brien County should be deleted and the new description added should be officially included into the Primary System.

Iowa 388 begins in the City of Calumet and travels easterly approximately ¼ mile to a junction with US 59.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 388 and its extensions in O'Brien County as follows:

Calumet:

Beginning at Morse Street connecting with an unnamed street; thence easterly on said unnamed street to the east corporation line, connecting with an unnamed street.

Beginning again on the east corporation line of the City of Calumet connecting with an unnamed street; thence easterly following substantially the center section line of Section 22-T94N-R40W to a point (junction US 59) near the E ¼ Corner Section 22-T94N-R40W, O'Brien County.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 388 in O'Brien County, Iowa.
