Transfer of jurisdiction agreement number 97-TJ-002, between the Iowa Department of Transportation and Wapello County, transferred Iowa 389 to Wapello County on September 15, 1997.

It is recommended that Iowa 389 in Wapello County be deleted from the Primary Road System

Iowa 389 begins at the entrance to the Ottumwa Municipal Airport, and travels southerly and easterly to US 63 approximately 5 ½ miles north of Ottumwa, Iowa.

Due to a review of our Primary Road System Records Iowa 389 in Wapello County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 389 in Wapello County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 389 and its extensions in Wapello County as follows:

Beginning at a point approximately 1850 feet north of the W $\frac{1}{4}$ Corner Section 25-T73N-R14W (entrance to the Ottumwa Municipal Airport); thence southerly following substantially the section line of Section 25-T73N-R14W to a point approximately 600 feet north of the W $\frac{1}{4}$ Corner said Section 25; thence curving southeasterly to a point approximately 600 feet east of the W $\frac{1}{4}$ Corner said Section 25; thence easterly following substantially the center section line said Section 25 to a point near the E $\frac{1}{4}$ Corner Section 25-T73N-R14W (junction US 63).
