DISCUSSION/BACKGROUND:

With the new four-lane Avenue of the Saints being opened from Donnellson south to the Missouri State Line on March 15, 2005, Iowa 394 should be removed from our system.

Certain segments of former Iowa 394 physically remained and were connected to the new four-lane to provide continuity. Some sections were removed to build the new four-lane and the remaining portions of old Iowa 394 should be designated Unsigned Iowa 460 until they transfer to Lee County in accord with transfer of jurisdiction agreement number 2003-TJ-003 which was approved by Commission Order Number H-2003-27.

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number TJ-091-0 (1) --2M-56, between Lee County and the Iowa Department of Transportation, transferred the section of road from the Iowa-Missouri State line approximately 1600 feet south and 100 feet east of the NW Corner Section 4-T65N-R6W north to US 218 approximately

850 feet north of the SW Corner Section 9–T67N–R6W to state jurisdiction on July 1, 1980. The section is now designated as Iowa 394.

Iowa 394 commences on the Iowa–Missouri State line approximately ten miles northwest of the corporation limits of the City of Keokuk and proceeds northerly to a junction with US 218 approximately ten miles west of the corporation limits of the City of Fort Madison.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve including the attached description of Iowa 394 in Lee County in the primary road system.

Locate Iowa 394 in Lee County as follows:

Beginning on the Iowa–Missouri State line at a point approximately 1600 feet south and 100 feet east of the NW Corner Section 4–T65N–R6W; thence northerly through said Section 4 to a point near the NW Corner Section 4–T65N–R6W; thence northerly following substantially the section line of Sections 33, 28, 21, 16, 9 and 4–T66N–R6W and Sections 33, 28, 21, 16 and 9–T67N–R6W to a point approximately 850 feet north of the SW Corner Section 9–T67N–R6W (junction US 218).

DISCUSSION/BACKGROUND:

Iowa 394 begins at a junction with Iowa 16 approximately nine miles, northeast of the City of Fort Madison and proceeds northeasterly to the Lee-Des Moines County line approximately 10 miles northeast of the City of Fort Madison.

Transfer of jurisdiction agreement number TJ-394-0 (1)--2M-56, between Lee County and the Iowa Department of Transportation, transferred Iowa 394 from a junction with Iowa 16 approximately ¼ mile east of the SW Corner Section 26-T69N-R4W northeasterly to the Lee-Des Moines County line in the NW ¼ of Section 25-T69N-R4W to county jurisdiction on August 25, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 394 in Lee County from the primary road system.

Remove Iowa 394 in Lee County as follows:

Beginning at a point approximately one-fourth mile east of the SW Corner Section 26-T69N-R4W (junction Iowa 16); thence northeasterly and northerly through Sections 26 and 25-T69N-R4W to the Lee-Des Moines County line (Skunk River) at a point in the NW ¼ said Section 25.

Beginning at a point approximately $\frac{1}{4}$ mile east of the SW Corner Section 26-T69N-R4W (junction Iowa 16); thence northeasterly and northerly through Sections 26 and 25-T69N-R4W to the Lee-Des Moines County line (Skunk River) at a point in the NW $\frac{1}{4}$ said Section 25.
