TITLE: Official Description Change: Iowa 395, Marshall County

DISCUSSION/BACKGROUND:

Iowa 395 begins on the north corporation line of the City of Melbourne, and travels northerly approximately 950 feet to Iowa 330.

Transfer of jurisdiction agreement number TJ-395-0 (1)--8M-64 between the Iowa Department of Transportation and Marshall County transferred Iowa 395 from the north corporation line of the City of Melbourne northerly to Iowa 330 approximately 185 feet south of the N $\frac{1}{4}$ Corner Section 6-T82N-R19W to County jurisdiction on December 12, 1983. The present description of Iowa 395 should be deleted to reflect this change in jurisdiction.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 395 in Marshall County from the primary road system.

Remove Iowa 395 in Marshall County as follows:

Beginning on the north corporation line of the City of Melbourne connecting with an unnamed street; thence northerly through Section 6-T82N-R19W to a point approximately 185 feet south of the N $\frac{1}{4}$ Corner of Section 6-T82N-R19W (junction Iowa 330).

DISCUSSION/BACKGROUND:

Iowa 395 begins in the City of Melbourne, and travels generally northwesterly approximately one-half mile to Iowa 330.

Transfer of jurisdiction agreement number TJ-395-0(2), between the City of Melbourne and the Iowa Department of Transportation, transferred that portion of Iowa 395 from the south line of Second Street northerly, westerly and northerly to the north corporation line to city jurisdiction on August 6, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 395 in Marshall County from the primary road system and approve including the attached new description of Iowa 395 in the primary road system.

Locate Iowa 395 in Marshall County as follows:

Beginning on the north corporation line of the City of Melbourne connecting with an unnamed street; thence northerly through Section 6-T82N-R19W to a point approximately 185 feet south of the N $\frac{1}{4}$ Corner of Section 6-T82N-R19W (junction Iowa 330).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 395 in Marshall County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 395 begins in Melbourne, Iowa and travels northerly terminating at the junction of Iowa 330 approximately 950 feet north of Melbourne, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 395 and its extension in Marshall County as follows:

Melbourne:

Beginning on the south line of Second Street; thence northerly, westerly, and northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Melbourne connecting with an unnamed street; thence northerly through Section 6-T82N-R19W (junction of Iowa 330) to a point approximately 185 feet south of the N ¼ Corner of Section 6-T82N-R19W.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 395 in Marshall County, Iowa.

NOTE: To become effective upon the adoption of this resolution.
