**DISCUSSION/BACKGROUND:**

Iowa 396 begins at a junction with Iowa 175 approximately 700 feet south of the City of Farnhamville and proceeds north to the City of Farnhamville.

Transfer of jurisdiction agreement number TJ-396-0 (1)--2M-13, between Calhoun County and the Iowa Department of Transportation, transferred that portion of Iowa 396 from a junction with Iowa 175 approximately 935 feet east of the S ¼ Corner Section 12-T86N-R31W north to the south corporation line of the City of Farnhamville to county jurisdiction on August 22, 1980.

Transfer of jurisdiction agreement number TJ-396-0 (2)--2M-13, between the City of Farnhamville and the Iowa Department of Transportation, transferred that portion of Iowa 396 from the south corporation line north to Commercial Street to city jurisdiction on August 11, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 396 in Calhoun County from the primary road system.

Remove Iowa 396 and its extension in Calhoun County as follows:

Beginning at a point approximately 935 feet east of the S ¼ Corner Section 12-T86N-R31W (junction of Iowa 175); thence north through Section 12-T86N-R21W to the south corporation line of the City of Farnhamville connecting with an unnamed street.

Farnhamville:

Beginning at the south corporation line connecting with an unnamed street; thence north to Commercial Street.
