**TITLE:** Official Description Change: Iowa 398, Poweshiek County

**DISCUSSION/BACKGROUND:**

Iowa 398 begins in the City of Brooklyn and travels northerly to US 6 approximately one-quarter mile north of the north corporation limits of the City of Brooklyn.

Due to a transfer of jurisdiction agreement number TJ-398-0 (3) --2M-79, between the City of Brooklyn and the Iowa Department of Transportation, that portion of Iowa 398 from Front Street northerly to the north corporation line was transferred to city jurisdiction on July 1, 1980.

Due to a transfer of jurisdiction agreement number TJ-398-0 (3) --2M-79, between the City of Brooklyn and the Iowa Department of Transportation and due to a transfer of jurisdiction agreement number TJ-398-0 (2) --2M-79, between Poweshiek County and the Iowa Department of Transportation, that portion of Iowa 398 along the corporation line of the City of Brooklyn for approximately 700 feet was transferred to local jurisdiction on July 1, 1980.

Due to a transfer of jurisdiction agreement number TJ-398-0 (2) --2M-79, between Poweshiek County and the Iowa Department of Transportation, that portion of Iowa 398 from the north corporation limits of the City of Brooklyn northerly approximately one-quarter mile to US 6 was transferred to county jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the description of Iowa 398 in Poweshiek County, as attached, be deleted from the primary road system.

Remove Iowa 398 and its extension in Poweshiek County as follows:

Brooklyn:

Beginning at East Front Street on an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Brooklyn connecting with an unnamed street; thence northerly through Section 14-T80N-R14W to a junction with US 6 at a point near the N ¼ Corner Section 14-T80N-R14W.

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records Iowa 398 in Poweshiek County has been corrected and the new description added should be officially included into the Primary System.

Iowa 398 begins in Brooklyn, and travels northerly approximately 1 mile to a junction with US 6.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 398 and its extension in Poweshiek County as follows:

Brooklyn:

Beginning at East Front Street on an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Brooklyn connecting with an unnamed street; thence northerly through Section 14-T80N-R14W to a junction with US 6 at a point near the N  $\frac{1}{4}$  Corner Section 14-T80N-R14W.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 398 in Poweshiek County, Iowa.
