**DISCUSSION/BACKGROUND:**

Iowa 408 begins at US 169 approximately seven miles west of the City of Lu Verne, and travels generally easterly into the City of Lu Verne.

Transfer of jurisdiction agreement number TJ-408-0 (4)--2M-55 between Kossuth County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ-408-0 (2)--2M-46 between Humboldt County and the Iowa Department of Transportation transferred that portion of Iowa 408 from US 169 easterly along the Kossuth-Humboldt County line to the north corporation line of the City of Lu Verne to local jurisdiction on July 18, 1980.

Transfer of jurisdiction agreement number TJ-408-0 (4)--2M-55 between Kossuth County and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-408-0 (3)--2M-46 between the City of Lu Verne and the Iowa Department of Transportation transferred that portion of Iowa 408 from the north corporation line of the City of Lu Verne easterly along the north corporation line of the City of Lu Verne (Kossuth-Humboldt County line) to the west corporation line of the City of Lu Verne to local jurisdiction on July 18, 1980.

Transfer of jurisdiction agreement number TJ-408-0 (3)--2M-46, between the City of Lu Verne and the Iowa Department of Transportation transferred that portion of Iowa 408 from the west corporation line easterly and northerly to Smart Street to city jurisdiction on July 15, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 408 in Kossuth County from the primary road system.

Remove Iowa 408 and its extension in Kossuth County as follows:

Beginning on the Kossuth–Humboldt County line at a point near the NW Corner Section 36–T94N–R29W, Kossuth County (NW Corner Section 1–T93N–R29W, Humboldt County) (junction US 169); thence easterly along the Kossuth–Humboldt County line (see Humboldt County) to the west corporation line of the City of Lu Verne connecting with an unnamed street.

Lu Verne:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and northerly to the north side of Smart Street.

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System Records, Iowa 408 in Kossuth County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 403 in Kossuth County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 408 and its extension in Kossuth County as follows:

Beginning on the Kossuth–Humboldt County line at a point near the Corner Section 36–T94N–R29, Kossuth County (NW Corner Section 1–T93N–R29W, Humboldt County) (junction US 169); thence easterly along the Kossuth–Humboldt County line (see Humboldt County) to the west corporation line of the City of Lu Verne connecting with an unnamed street.

Lu Verne:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and northerly to the north side of Smart Street.
