Iowa 408 begins at a junction with US 169 approximately seven miles west of the City of Lu Verne and proceeds easterly into the City of Lu Verne.

Transfer of jurisdiction agreement number TJ-408-0 (2) --2M-46 between Humboldt County and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-408-0 (4) --2M-55 between Kossuth County and the Iowa Department of Transportation, transferred that portion of Iowa 408 from a junction with US 169 on the Humboldt-Kossuth County line near the NW Corner Section 1-T93N-R29W east to the west corporation line of the City of Lu Verne to local jurisdiction on July 15, 1980.

Transfer of jurisdiction agreement number TJ-408-0 (3) --2M-46 between the City of Lu Verne and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-408-0 (4) --2M-55 between Kossuth County and the Iowa Department of Transportation, transferred that portion of Iowa 408 from the west corporation line of the City of Lu Verne east along the north corporation line to the west corporation line of the City of Lu Verne to local jurisdiction on July 15, 1980.

Transfer of jurisdiction agreement number TJ-408-0 (3) --2M-46, between the City of Lu Verne and the Iowa Department of Transportation, transferred that portion of Iowa 408 from the west corporation line of the City of Lu Verne east to DeWitt Street to city jurisdiction on July 15, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 408 in Humboldt County from the primary road system.

Remove Iowa 408 and its extension in Humboldt County as follows:

Beginning on the Humboldt-Kossuth County line at a point near the NW Corner Section 1-T93N-R29W, Humboldt County (SW Corner Section 36-T94N-R29W, Kossuth County) (junction of US 169); thence easterly along the Humboldt-Kossuth County line, following substantially the section line of Section 1-T93N-R29W and Sections 6, 5, 4, 3, 2, and 1-T93N-R28W to the west corporation line of the City of Lu Verne connecting with an unnamed street.

Lu Verne:

Beginning on the west corporation line, connecting with an unnamed street; thence easterly approximately 1450 feet, connecting with an unnamed street.

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 408 in Humboldt County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 403 begins at junction US 169 on the Humboldt-Kossuth County line approximately 5 miles northwest of Livermore and travels easterly along the Humboldt-Kossuth County line terminating in Lu Verne, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 408 and its extension in Humboldt County as follows:

Beginning on the Humboldt-Kossuth County line at a point near the NW Corner Section 1-T93N-R29W, Humboldt County (SW Corner Section 36-T94N-R29W, Kossuth County) (junction of US 169); thence easterly along the Humboldt-Kossuth County line, following substantially the section line of Section 1-T93N-R29W and Sections 6, 5, 4, 3, 2, and 1-T93N-R28W to the west corporation line of the City of Lu Verne connecting with an unnamed street.

Lu Verne:

Beginning on the west corporation line, connecting with an unnamed street; thence easterly approximately 1450 feet, connecting with an unnamed street. (NOTE: See Kossuth County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 408 in Humboldt County, Iowa.
