DISCUSSION/BACKGROUND:

Iowa 412 begins at US 63 in the City of Waterloo, and travels easterly and northeasterly to US 218 in the City of Waterloo.

Transfer of jurisdiction agreement number TJ-412-1 (5) --2M-07 between the City of Waterloo and the Iowa Department of Transportation transferred Iowa 412 from US 63 to US 218 to City jurisdiction on October 1, 1983. The State Functional Classification was changed to Municipal Arterial on October 25, 1983. The present description of Iowa 412 should be deleted to reflect this change in jurisdiction.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 412 in Black Hawk County from the primary road system.

Remove Iowa 412 in Black Hawk County as follows:

Waterloo:

Beginning at the intersection of Sergeant Road and Murphy Road; thence easterly and northeasterly to a point on LaPorte Road in Waterloo, Iowa.
