TITLE: Iowa 475 in Monona County

Locate Iowa 475 in Monona County, Iowa, as follows:

Onawa:

Beginning on West Broadway at the north line of Iowa Avenue; thence northerly on West Broadway to the north corporation line.

Beginning on the north corporation line of the City of Onawa, connecting with West Broadway; thence north to a point near the W $\frac{1}{4}$ Corner Section 33-T84N-R45W; thence in a northeasterly direction crossing the Chicago and Northwestern Railway overpass, and in a northwesterly direction through the west part of Section 33-T84N-R45W; to a point near the NW Corner Section 33-T84N-R45W; thence in a northwesterly direction along the east side of the Chicago and Northwestern Railway and substantially parallel thereto through Section 20, 29, 18 and 7-T84N-R46W to the south corporation line of the Town of Whiting, connecting with an unnamed street at a point approximately 300 feet east of the center of Section 1-T84N-R46W.

Whiting:

Beginning on an unnamed street at the south corporation line; thence northwesterly on said unnamed street to the west corporation line.

Beginning again on the west corporation line of the Town of Whiting, connecting with an unnamed street at a point approximately 100 feet south of the W $\frac{1}{4}$ Corner of Section 36-T85N-R46W; thence in a

northwesterly direction along the east side of the Chicago and Northwestern Railway and substantially parallel thereto through Section 35, 26, 23, 22, 15, 9, 4 and 5-T85N-R46W to the Monona-Woodbury County line at a point approximately 700 feet west of the NE Corner Section 5-T85N-R46W, Monona County (SE Corner Section 32-T86N-R46W, Woodbury County)

NOW THEREFORE: Be it resolved that the Iowa State Highway Commission approve the location of Iowa 475 in Monona County, Iowa.

NOTE: To become effective upon adoption of this resolution.

Beginning on the north corporation line of the City of Onawa, connecting with West Broadway; thence north to a point near the W $\frac{1}{4}$ Corner Section 33-T84N-R45W; thence in a northeasterly direction crossing the Chicago and Northwestern Railway overpass, and in a northwesterly direction through the west part of Section 33-T84N-R45W to a point near the NW Corner Section 33-T84N-R45W; thence in a northwesterly direction along the east side of the Chicago and Northwestern Railway and substantially parallel thereto, through Section 29, 20, 18 and 7-T84N-R46W to the south corporation line of the Town of Whiting connecting with an unnamed street at a point approximately 300 feet east of the center of Section 1-T84N-R46W.

Beginning again on the west corporation line of the Town of Whiting, connecting with an unnamed street at a point approximately 100 feet south of the W $\frac{1}{4}$ Corner of Section 36-T85N-R46W; thence in a

northwesterly direction along the east side of the Chicago and Northwestern Railway and substantially parallel thereto through Section 35, 26, 23, 22, 15, 9, 4 and 5-T85N-R46W to the Monona-Woodbury County line at a point approximately 700 feet west of the NE Corner Section 5-T85N-R46W, Monona County (SE Corner Section 32-T86N-R46W, Woodbury county).
