DISCUSSION/BACKGROUND:

Due to the relocation of US 20 to the Iowa 520 alignment in Hamilton County, Iowa 520 in Hamilton County should be deleted from the primary road system.

Iowa 520 begins with a junction with Iowa 17 in the City of Webster City and proceeds easterly to a junction with Interstate 35 approximately twelve miles east of the City of Webster City.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 520 in Hamilton County from the primary road system.

Remove Iowa 520 and its extension in Hamilton County as follows:

Webster City:

Beginning on an unnamed street at Superior Street (junction Iowa 17); thence; easterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Webster City connecting with an unnamed street; thence easterly following substantially the center section line of Sections 7, 8, 9, 10, 11, and 12-T88N-R25W; Sections 7, 8, 9 (junction US 69), 10, 11, and 12-T88N-R24W and Section 7-T88N-R23W (junction Interstate 35) to the east ramps of Interstate 35.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records, Iowa 520 in Hamilton County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 520 in Hamilton County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 520 and its extension in Hamilton County as follows.

Webster City:

Beginning on an unnamed street at Superior Street (junction Iowa 17); thence easterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Webster City connecting with an unnamed street; thence easterly following substantially the center section line of Sections 8, 9, 10, 11, and 12-T83N-R25W; Sections 7, 8, 9 (junction US 69), 10, 11, and 12-T88N-R24W and Section 7-T88N-R23W (junction Interstate 35) to the east ramps of Interstate 35.

Remove from the Primary Road System the road,

Add to the Primary Road System the road,

Beginning at the Hamilton–Webster County line near the SW Corner NW ¼ Section 7–T88N–R26W, Hamilton County (SE Corner NE ¼ Section 12–T88N–R27W, Webster County); thence easterly following substantially the quarter section line to the Hamilton–Hardin County line near the SE Corner NE ¼ Section 12–T88N–R23W, Hamilton County (SW Corner NW ¼ Section 7–T88N–R22W, Hardin County).

Access Control Classification,

This section of road will be a Class I Road.

BE IT FURTHER RESOLVED THAT THE DESCRIPTION OF Iowa 520 in Hamilton County and the attached description is adopted.
