Transfer of jurisdiction agreement number 95-TJ-003 between the Iowa Department of Transportation and the City of Ames transferred Unsigned Iowa 930 to the City of Ames on October 24, 1995.

**PROPOSAL / ACTION RECOMMENDATION:**

It is recommended that Unsigned Iowa 930 in Ames be deleted from the Primary Road System.

New Description – Unsigned Iowa 930 in Story County described as follows:

Beginning at the NW Corner Section 7-T83N-R24W, Story County (NE Corner Section 12-T83N-R25W, Boone County); then east following substantially the section line through Section 7-T83N-R24W to the west corporation line of Ames, connecting with Lincoln Way.

**TITLE:** Official Description Change: Unsigned Iowa 930, Story County

**DISCUSSION/BACKGROUND:**

Unsigned Iowa 930 begins at the Story-Boone County line approximately one-half mile west of the west corporation limits of the City of Ames, and travels easterly to the west corporation limits of the City of Ames, it begins again at a junction with US 69 in the City of Ames and travels easterly via the

Cities of Nevada and Colo to the Story–Marshall County line approximately four miles east of the City of Colo.

Transfer of jurisdiction agreement number TJ–930–0(18), between Story County and the Iowa Department of Transportation, transferred that portion of unsigned Iowa 930 from the east corporation limits of the City of Ames approximately 0.12 mile west of the NW Corner Section 7–T83N–R23W easterly to the west corporation line of the City of Nevada approximately 0.15 mile west of the NW Corner Section 12–T83N–R23W, from the east corporation line of the City of Nevada easterly to the west corporation line of the City of Colo, and from the east corporation line of the City of Colo easterly to the Story–Marshall County line near the NE Corner Section 12–T83N–R21W to County jurisdiction on August 25, 1980.

Transfer of jurisdiction agreement number TJ–930–0 (18), between Story County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ–930–0(19), between the City of Ames and the Iowa Department of Transportation, transferred that portion of unsigned Iowa 930 from the east corporation limits of the City of Ames approximately one-half mile east of the NW Corner Section 7–T83N–R23W easterly along the south corporation limits approximately one-half mile to the east corporation limits of the City of Ames to local jurisdiction on August 25, 1980.

Transfer of jurisdiction agreement number TJ–930–0(19), between the City of Ames, and the Iowa Department of Transportation, transferred that portion of unsigned Iowa 930 from the junction of US 69 easterly to the east corporation line to city jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ–930–0 (18), between Story County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ–930–0 (1), between the City of Nevada and the Iowa Department of Transportation, transferred that portion of unsigned Iowa 930 from approximately 0.15 mile west of the NW Corner Section 12–T83N–R23W easterly along the north corporation line of the City of Nevada to local jurisdiction on August 25, 1980.

Transfer of jurisdiction agreement number TJ-930-0(1), between the City of Nevada and the Iowa Department of Transportation, transferred that portion of unsigned Iowa 930 from the west corporation line easterly to the east corporation line to city jurisdiction on July 28, 1980.

Transfer of jurisdiction agreement number TJ-930- (18), between Story County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ-930-0 (16), between the City of Colo and the Iowa Department of Transportation, transferred that portion of unsigned Iowa 930 from near the NW Corner Section 8-T83N-R21W easterly along the north corporation line of the City of Colo to near the NE Corner Section 8-T83N-R21W to local jurisdiction on November 7, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the present description of unsigned Iowa 930 in Story County from the primary road system and approve including the attached new description of unsigned Iowa 930 in the primary road system.

Locate unsigned Iowa 930 in Story County as follows:

Beginning at the NW Corner Section 7-T83N-R24W, Story County (NE Corner Section 12-T83N-R25W, Boone County); thence east following substantially the section line through Section 7-T83N-R24W to the west corporation line of the City of Ames.

**DISCUSSION/BACKGROUND:**

Unsigned Iowa 930 begins at the Story-Boone County line approximately  $\frac{3}{4}$  mile west of Ames and travels easterly via Ames and Nevada to the Story-Marshall County line approximately 4 miles east of Colo, Iowa.

Due to a review of our Primary Road System records Unsigned Iowa 930 in Story County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Unsigned Iowa 930 in Story County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate unsigned Iowa 930 and its extensions in Story County as follows:

Beginning at the NW Corner Section 7-T83N-R24W, Story County (NE Corner Section 12T83N-R25W, Boone County); thence east following substantially the

section line through Section 7–T83N–R24W to the west corporation line of the City of Ames connecting with an unnamed street.

Ames:

Beginning at Duff Avenue on an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of the City of Ames connecting with an unnamed street; thence easterly following substantially the section line through Sections 7, 8, 9, 19, 11 and 12–T83N–R23W to the west corporation line of the City of Nevada connecting with an unnamed street.

Nevada:

Beginning at the west corporation line, connecting with an unnamed street; thence easterly to the east corporation line, connecting with an unnamed street.

Beginning again at the east corporation line of the City of Nevada connecting with an unnamed street; thence east following substantially the section line through Sections 8, 9, and 10–T83N–R22W to a point approximately 700 feet west of the N  $\frac{1}{4}$  Corner Section 10–T83N–R22W; thence southeasterly and northeasterly through the north part of Section 10–T83N–R22W, crossing the Chicago, Rock Island and Pacific Railroad to a point near the NE Corner Section 10–T83N–R22W; thence east following substantially the section line through Sections 11, 12–T83N–R22W and Sections 7, 8, 9, 10, 11 and 12–T83N–R21W to a point near the NE Corner Section 12T83N–R21W, Story County, (NW Corner Section 7–T83N–R20W, Marshall County).

**DISCUSSION/BACKGROUND:**

US 30 Alternate should be updated to Unsigned Iowa 930 in Story County, Iowa and be officially included in the State Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Unsigned Iowa 930 as follows:

Beginning at the NW Corner Section 7-T83N-R24W, Story County (NE Corner Section 12-T83N-R25W, Boone County); thence east following substantially the section line through Section 7-T83N-R24W to the west corporation line of the City of Ames connecting with Lincoln Way.

Ames:

Beginning at Duff Avenue on Lincoln Way; thence east on Lincoln Way to the east corporation line.

Beginning again at the east corporation line of the City of Ames connecting with Lincoln Way; thence easterly following substantially the section line through Sections 7, 8, 9, 10, 11, and 12-T83N-R23W to the west corporation line of the City of Nevada connecting with Lincoln Way.

Nevada:

Beginning on Lincoln Way at the west corporation line; thence east on Lincoln Way to the east corporation line.

Beginning again at the east corporation line of the City of Nevada connecting with Lincoln Way; thence east following substantially the section line through Sections 8, 9, and 10-T83N-R22W to a point approximately 700 feet west of the N  $\frac{1}{4}$  Corner Section 10-T83N-R22W; thence southeasterly and northeasterly through the north part of Section 10-T83N-R22W, crossing the Chicago, Rock Island and Pacific Railroad to a point near the NE Corner Section 10-T83N--R22W; thence east following substantially the section line through Sections 11, 12-T83N-R22W and Sections 7, 8, 9, 10, 11, and 12-T83N-R21W to a point near the NE Corner Section 12-T83N-R21W, Story County, (NW Corner Section 7-T83N-R20W, Marshall County).

NOW THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Unsigned Iowa 930 in Story County, Iowa.

NOTE: To become effective upon adoption of this resolution.
